Overseas Trade Statistics (OTS): Revisions to Data (July 2015)

Following quality assurance and checking procedures, Trade Statistics has identified a number of areas where businesses had submitted trade incorrectly on their original trade declarations.

Given the scale and the impact of the changes on trade statistics, HMRC has revised the trade figures for 2008 to 2014. These revisions have been released today in line with the UK Statistical Authority Code of Practice for Official Statistics and the HMRC Trade Statistics Revision Policy.

The Revisions

Revisions are being made to the value data for the commodities listed below for the relevant months and, where appropriate, to the associated net mass and the supplementary unit data.

Exports

Organic o-Xylene - Revision 2011-2013

This change involves amending misclassified declarations for UK exports to the Netherlands for 2011-2013. In total, the change will affect two commodity codes over twenty two months. This will result in a transfer of £79.7 million for 2011, £81.9 million for 2012, and £22.3 million for 2013 for exports to the Netherlands.

Figure 1: Value (£) of monthly UK exports to EU countries for commodity code 29024100, 2011-2013




Figure 2: Value (£) of monthly UK exports to EU countries for commodity code 29024400, 2011-2013

Food Products & Preparations – Revision 2013

This change involves amending and deleting published trade for UK exports to four countries in the EU in 2013. In total, the change will affect eleven separate commodity codes over four months (September, October, November and December 2013). This will result in a change of £1.9 million between commodity codes for exports to the countries in the EU for 2013.

Palladium - Revision 2008-2009

This change involves amending published trade of net masses and supplementary units for UK exports to the EU between 2008 and 2009. In total, the change will affect one commodity code. This will result in a decrease of 2.0 million kg for exports for 2008, an increase of 6,216 g supplementary units for exports for 2008, and a decrease of 4.8 million kg for exports for 2009.



Figure 7: Net mass (kg) of monthly UK exports to EU countries for Chapter 71, 2008





Figure 8: Net mass (kg) of monthly UK exports to EU countries for Chapter 71, 2009



This change involves amending misclassified declarations and supplementary units of UK exports to two EU countries in 2012. In total, the change will affect two commodity codes over eleven months and will result in a transfer of £673,436 between commodity codes and a decrease of 11,797 supplementary units for EU countries over this period.



Figure 10: Value (£) of monthly UK exports to EU countries for commodity code 27111100, 2012






Figure 11: Value (£) of monthly UK exports to EU countries for commodity code 27111900, 2012

Figure 12: Value (£) of monthly UK exports to Non-EU countries for commodity code 27111100, 2011




Figure 13: Value (£) of monthly UK exports to Non-EU countries for commodity code 28042990, 2011




Figure 14: Value (£) of monthly UK exports to Non-EU countries for commodity code 36061000, 2011





Figure 15: Value (£) of monthly UK exports to Non-EU countries for commodity code 38247900, 2011

Platinum - Revision 2009

This revision involves amending a misclassified declaration for UK exports to South Korea in 2009. In total, the change will affect two commodity code over one month (August 2009). This will result in a decrease of £5,161 and 101,200kg for the misclassified declaration, and an increase of 1,120

supplementary units for amending declarations for exports to South Korea for 2009.



Beef - Revision 2012-2013

This revision involves amending misclassified declarations for the values and country error of UK exports to two Non-EU countries between 2012 and 2013. Due to the foot and mouth outbreak in 2004, all beef exports were banned to China and so these misclassified declarations legally should not exist. In total, the changes will affect six commodity codes over fifteen months. This will result in amendments of £101,612 for 2012 and £189,250 for 2013 across the commodities for exports to Non-EU countries.

Figure 17: Value (£) of monthly UK exports to Non-EU countries for commodity code 02021000, 2013





Figure 18: Value (£) of monthly UK exports to Non-EU countries for commodity code 02022030, 2012-2013

In total, the change will result in a decrease of 2,979 kg for exports to EU countries for 2012, and 29,968 kg for exports to EU countries for 2013, within Chapter 71.




Figure 19: Net mass (kg) of monthly UK exports to EU countries for HS4 level 7108, 2012-2013




Figure 20: Value (£) per net mass (kg) of monthly UK exports to EU countries for HS4 level 7108, 2012-2013

This revision involves amending trade declarations for the net masses of UK exports to Non-EU countries for 2012 and 2013. In total, the changes will affect four commodity codes over six months. This will result in decreases of 70 kg for 2012, and decreases of 105 kg for 2013 across the commodities for exports to Non-EU countries.

Imports

Natural Gas - Non-EU Revision 2011-2014

This revision involves 2 separate trade challenges. The first trade challenge involves amending trade declarations for values of UK imports from Norway between 2011 and 2014. The changes for this challenge will affect six commodity codes over thirty eight months. This will result in value increases of £1.4 billion for 2011, £2.5 billion for 2012, £3.1 billion for 2013, and £2.2 billion for 2014. Net mass changes will result in increases of 5.2 billion kg for 2011, 8.5 billion kg for 2012, 8.8 billion kg for 2013, and 8.3 billion kg for 2014.

Figure 21: Total Value of monthly UK imports from Norway for commodity code 27112100, 2010-2014




Figure 22: Total Value of monthly UK imports from Norway for commodity code 27111100, 2012-2014




Figure 23: Total Value of monthly UK imports from Norway for commodity code 27111211, 2013-2014




Figure 24: Total Value of monthly UK imports from Norway for commodity code 27111297, 2013-2014




Figure 25: Total Value of monthly UK imports from Norway for commodity code 27111310, 2013-2014





Figure 26: Total Value of monthly UK imports from Norway for commodity code 27111900, 2013-2014

Figure 27: Total Net mass of monthly UK imports from Norway for commodity code 27112100, 2010-2014




Figure 28: Total Net mass of monthly UK imports from Norway for commodity code 27111100, 2012-2014




Figure 29: Total Net mass of monthly UK imports from Norway for commodity code 27111211, 2013-2014




Figure 30: Total Net mass of monthly UK imports from Norway for commodity code 27111297, 2013-2014




Figure 31: Total Net mass of monthly UK imports from Norway for commodity code 27111310, 2013-2014





Figure 32: Total Net mass of monthly UK imports from Norway for commodity code 27111900, 2013-2014



The second revision involves amending a single value declaration for UK imports from Trinidad and Tobago in 2013. In total, the change will affect one commodity code over one month (October 2013). This will result in an increase of £6.2 million for imports from Trinidad and Tobago for 2013.

Table 17 shows the impact the changes will have on the annual value in the individual commodity code involved in this revision.

Figure 33: Value (£) of monthly UK imports from Trinidad & Tobago for commodity code 27111100, 2013



Figure 34: Total Value of monthly UK imports from Non-EU countries for commodity code 27112100, 2010-2014




Figure 35: Total Value of monthly UK imports from Non-EU countries for commodity code 27111100, 2012-2014




Figure 36: Total Value of monthly UK imports from Non-EU countries for commodity code 27111211, 2013-2014




Figure 37: Total Value of monthly UK imports from Non-EU countries for commodity code 27111297, 2013-2014




Figure 38: Total Value of monthly UK imports from Non-EU countries for commodity code 27111310, 2013-2014





Figure 39: Total Value of monthly UK imports from Non-EU countries for commodity code 27111900, 2013-2014

Figure 40: Total Net mass of monthly UK imports from Non-EU countries for commodity code 27112100, 2010-2014




Figure 41: Total Net mass of monthly UK imports from Non-EU countries for commodity code 27111100, 2012-2014




Figure 42: Total Net mass of monthly UK imports from Norway for commodity code 27111211, 2013-2014




Figure 43: Total Net mass of monthly UK imports from Norway for commodity code 27111297, 2013-2014




Figure 44: Total Net mass of monthly UK imports from Norway for commodity code 27111310, 2013-2014





Figure 45: Total Net mass of monthly UK imports from Norway for commodity code 27111900, 2013-2014

Figure 46: Value (£) of monthly UK exports to Non-EU countries for commodity code 27071000, 2013




Figure 47: Value (£) of monthly UK exports to Non-EU countries for commodity code 27071090, 2009-2012





Figure 48: Value (£) of monthly UK exports to Non-EU countries for commodity code 29022000, 2009-2013

Figure 49: Value (£) of monthly UK imports from Non-EU countries for commodity code 40112010, 2012-2013





Figure 50: Value (£) of monthly UK imports from Non-EU countries for commodity code 40112090, 2012-




Figure 52: Value (£) of monthly UK imports from EU countries for Chapter 11, 2013




Figure 53: Value (£) of monthly UK imports from EU countries for Chapter 20, 2013




Figure 54: Value (£) of monthly UK imports from EU countries for Chapter 35, 2013



Figure 57: Value (£) of monthly UK imports from Non-EU countries for commodity code 84331190, 2008-2010




Figure 58: Value (£) of monthly UK imports from Non-EU countries for commodity code 84331190, 2013




Figure 59: Value (£) of monthly UK imports from Non-EU countries for commodity code 84339000, 2008-2010





Figure 60: Value (£) of monthly UK imports from Non-EU countries for commodity code 84339000, 2013




Figure 61: Net mass (kg) of monthly UK imports from EU countries for HS4 level 7108, 2012-2013




Figure 62: Value (£) per net mass (kg) of monthly UK imports from EU countries for HS4 level 7108, 2012-2013


