EU Overseas Trade Statistics (OTS): Revisions to Data (July 2014)

Following quality assurance and checking procedures, Trade Statistics has identified a number of areas where businesses had submitted trade incorrectly on their original trade declarations.

Given the scale and the impact of the changes on trade statistics, HMRC have revised the trade figures for 2005 to 2012. These revisions have been released today in line with the UK Statistical Authority Code of Practice for Official Statistics and the HMRC Trade Statistics Revision Policy.

The revisions, made for each affected period, are:

The Revisions

Revisions are being made to the value data for the commodities listed below for the relevant months and, where appropriate, to the associated net mass and the supplementary unit data.

Mineral fuels - Revision 2012

This change involves amending country destinations for declarations of UK exports to Germany, and one classification for exports to Cyprus in 2012. In total, the change will affect three commodity codes over two months and will result in a decrease of £0.7 million and a transfer of £42.5 million between countries, and a transfer of £30.5 million between commodity codes over this period.

Tables 1 and 2 show the impact the changes will have on the annual values and net mass in the individual commodities involved in this revision.





Figure 2: Value of UK monthly exports to Cyprus for commodity code 27101964







Pharmaceuticals and Chemicals - Revision 2010

This change involves amending published trade for UK imports from the Netherlands in 2010. In total, the change will affect three commodity codes over nine months. This will result in a decrease of £492.4 million for imports from the Netherlands for 2010.













Figures 10 to 12 show how the changes will affect the net mass, on a monthly basis for the commodities affected by this revision.

This change involves amending published net mass declarations for UK imports and exports from the EU for several years. In total, the change will affect three commodity codes within HS4 7108 (Gold, incl. gold plated with platinum, unwrought or not further worked than semi-manufactured or in powder form).





Motor cars - Revision 2010 - 2011

This change involves amending published trade for UK imports from the Czech Republic in 2010 and 2011. In total, the change will affect two separate commodity codes over fifteen months. This will result in a decrease of £2.9 million and a transfer of £14.7 million between commodity codes for imports from the Czech Republic for 2010, and decrease of £10.8 million and a transfer of £122.3 million for 2011.







This change involves amending published trade for UK imports from Denmark in 2012. In total, the change will result in an increase of £31.3 million for imports from Denmark for 2012 within Chapter 88 (Aircraft, spacecraft, and parts thereof).





Other Products - EU Imports Revision 2010 - 2012

This change involves amending published trade for UK imports from the EU in 2010, 2011 and 2012. In total, the change will affect four separate commodity codes, in three separate chapters. This will result in a transfer of £18.6 million between commodity codes for imports from the EU for 2010, £22.4 million for 2011, and £17.9 million for 2012, and a decrease of 887,912 kg for 2012.







Figure 21: Value of monthly imports from the EU for commodity code 84879090












Figure 26: Net mass of monthly imports from the EU for commodity code 99319900





Other Products - EU Exports Revision 2010 - 2012

This change involves amending published trade for UK exports to the EU in 2010, 2011 and 2012. In total, the change will affect three separate commodity codes, in two separate chapters. This will result in a transfer of £162.4 million between commodity codes for imports from the EU for 2010, £105.5 million for 2011, and £4.7 million for 2012.

Figure 28: Value of monthly exports to the EU for commodity code 85176200






Figure 29: Value of monthly exports to the EU for commodity code 99319900










Figure 32: Net mass of monthly exports to the EU for commodity code 99319900





Figure 33: Net mass of monthly exports to the EU for commodity code 99500000
