1. Consultation overview

- 1.1 The Competition and Markets Authority (CMA) is consulting on updates to its Prioritisation Principles, which were published in 2014.¹
- 1.2 The CMA proposes to update the Prioritisation Principles to reflect changes to the context in which we operate since they were published (including, for example, the UK's exit from the EU). Importantly, this includes reflecting the CMA's wider strategic aims, as outlined in our 2023/2024 Annual Plan.² The CMA is also proposing to take the opportunity to streamline the Prioritisation Principles.
- 1.3 The proposed updated Prioritisation Principles, on which the CMA is consulting, are published <u>here</u> on the CMA webpages.

Background

- 1.4 To make efficient and effective use of public resources allocated to the CMA to promote competitive markets and tackle unfair behaviour in the interests of people, businesses and the UK economy, the CMA needs to ensure that we take appropriate decisions about which projects and programmes of work we undertake, across all areas of our responsibility. This is particularly true as the CMA does not have the resources to act in all instances where intervention would bring benefits.
- 1.5 To effectively prioritise our work, the CMA needs to consider a range of factors. The Prioritisation Principles set out the factors that the CMA will consider before deciding whether to take action in the areas which are subject to our remit and where we have discretion to act (save where these are governed by a separate prioritisation framework).³ The principles consist of five key considerations:
 - (a) **Strategic significance**: does CMA action in this area fit with the CMA's objectives and strategy?
 - (b) Impact: how substantial is the likely positive impact of CMA action?
 - (c) **Is the CMA best placed to act**: is there an appropriate alternative to CMA action?
 - (d) **Resources**: does the CMA have the right capacity in place to act effectively?
 - (e) **Risk**: what types of risks are associated with CMA action, and how significant are they?
- 1.6 The Principles also set out in more detail how the CMA uses these considerations to prioritise its work.

1.7 The proposed updated Prioritisation Principles build on those first introduced by the Office of Fair Trading in 2008, and subsequently updated when the CMA was established in 2014.

Updates to the Prioritisation Principles

- 1.8 A number of things have changed since the CMA's current Prioritisation Principles were published in 2014. The UK is no longer part of the EU, and there have been changes to the CMA's responsibilities and functions. In its 2023/2024 Annual Plan, the CMA has also set out a longer-term strategy, identifying medium-term priorities (which cover a three-year time horizon) as well as annual areas of focus, all of which flow from an overarching purpose and ambitions.
- 1.9 Consequently, the CMA proposes to update the Prioritisation Principles in line with these changes. Specifically, to:
 - (a) Bring the principles in line with the CMA's purpose, ambition and strategy as set out in our 2023/2024 Annual Plan. We consulted on these extensively when preparing our 2023/2024 Annual Plan, and are not seeking views on these at this time.
 - (b) Clarify how the strategic considerations in the Prioritisation Principles relate to the strategic priorities in the CMA's Annual Plans.
 - (c) Streamline and simplify the text, so it is shorter and easier to read. For example, the 2014 Principles had a separate section of explanatory notes, but we propose to integrate these into the main text of the proposed updated Prioritisation Principles.
 - (d) Separate out 'is the CMA best placed to act?' as a principle (before it was subsumed in 'strategic significance'). Although the principles themselves are largely unchanged, we have also reordered the principles so that 'strategic significance' is the first consideration.
 - (e) Remove redundant references and update language to reflect changes since 2014. This includes, for example, the removal of references to the EU, adding appropriate references to the CMA's newer functions, and updating language to reflect the CMA's new strategy as outlined in the 2023/2024 Annual Plan.
 - (f) Better reflect the way that the Principles are used, for example when we would consider them, and when we might expect to review or update them.
- 1.10 Although this means that a number of amendments have been made to the text, the CMA's intention is primarily to align the Prioritisation Principles with the CMA's approach as set out in our Annual Plan, rather than to make additional significant changes of substance to the key considerations identified in the

Prioritisation Principles, or the way they are used. The CMA welcomes views on whether the updates successfully address the points highlighted above. The CMA is not seeking further views on the purpose, ambitions and strategic priorities set out in the 2023/2024 Annual Plan, as these have been consulted on separately.

Consultation process

How to respond

- 1.11 We are publishing this consultation document on the CMA webpages and drawing it to the attention of a range of stakeholders. We invite and welcome comments on our proposed amendments to the existing Prioritisation Principles. In light of the scope of the proposed updates, and as we are not consulting again on our strategy as set out in the 2023/2024 Annual Plan, we are seeking responses by 1700 on Thursday 3 August 2023).
- 1.12 We encourage you to respond to the consultation in writing (by email to *prioritisation.consultation@cma.gov.uk*) by the deadline set out below at paragraph 1.15. Please provide supporting evidence or examples for your views where possible.
- 1.13 When responding to this consultation, please state whether you are responding as an individual or are representing the views of a group or organisation. If the latter, please make clear who you are representing and their role or interest.
- 1.14 In accordance with our policy of openness and transparency, we will publish non-confidential versions of responses on our webpages. If your response contains any information that you regard as sensitive and that you would not wish to be published, please provide at the same time a non-confidential version for publication on our webpages which omits that material and which explains why you regard it as sensitive (see also paragraph 1.17 below).

Deadline for responses

1.15 The consultation will run from Thursday 6 July to Thursday 3 August 2023. Responses should be submitted by email by 5:00 p.m. on 3 August 2023 to prioritisation.consultation@cma.gov.uk.

1.16 In preparing this consultation document, the CMA has taken into account the published government consultation principles, which set out the principles that government departments and other public bodies should adopt when consulting with stakeholders.

When submitting your response, please also let us know if you wish to remain anonymous.
- 1.21 Please note that information and personal data provided in response to this consultation may be the subject of requests by members of the public under the Freedom of Information Act 2000. In responding to such requests, we will take fully into consideration representations made by you in support of confidentiality. We will also be mindful of our responsibilities under the data protection legislation referred to above and under Part 9 of the Enterprise Act 2002.

Next steps

1.23 After the consultation, the CMA will consider the submissions received and prepare a response. The CMA will publish its response and finalised Prioritisation Principles on <u>http://www.gov.uk/cma</u>.

1.24 The CMA will also publish the responses received during the consultation (with any confidential information redacted – see paragraph 1.14). These documents will be available on our webpages and respondents will be notified when they are available.

 - b) More specifically, do you think the proposed updated Prioritisation Principles provide greater clarity about the relationship between the CMA's prioritisation decisions and its strategic aims, when read alongside the CMA's Annual Plan?⁴
 - c) Do you have any other suggested updates that you would like the CMA to consider? Please give a clear justification for any further updates.
