

Biosecure Procurement Requirement Exception Form

Advice to Customers

All applications under England Woodland Creation offer (EWCO), Tree Health Pilot, Local Authority Treescapes Fund (LATF), Urban Tree Challenge Fund (UTCF) and HS2 Woodland Fund are subject to the Biosecure Procurement Requirement. This means that to be eligible for support under these grants you must source your plants from suppliers who can provide evidence that they meet the requirements set out in the Plant Health Management Standard, available at https://planthealthy.org.uk/. Please see the relevant grant manual for more details.

If you are not purchasing your trees from a commercial supplier, an exception to this requirement may be possible. This form is to be used by applicants, agreement holders and their agents to apply for this exception.

You must wait for the exception to be approved by the Forestry Commission in writing prior to sourcing the trees, to ensure your claims will be valid. We recommend exceptions are requested when you make your grant application.

Please note that exceptions can only be applied for by the main applicant or by an agent identified as having authority to make applications on the Agent Authority Form.
