JUDGMENT

The unanimous Judgment of the Employment Tribunal is that: -

There is no recommendation.

The claimant is awarded the sum of £34,051.63, inclusive of interest, as compensation for discrimination on the grounds of sex (sections 13, 26 and 27 Equality Act 2010).

Calculation of award

Age at dismissal: 28

Commencement of employment: 24/8/2020

Net monthly pay: £1636.96

Net daily pay: £53.82

Compensation for past loss of earnings:

Claimant unemployed for 113 days

113 days x £53.82 = £6081.66

Less pay in lieu of notice (one week) $-7 \times 53.82 = \text{\pounds}376.74$

= £5704.92

Plus loss of employer pension contribution = \pounds 174.27.

The sum awarded for loss of employer pension contribution is awarded gross and so is subject to any tax and national insurance payable which is to be deducted by the respondent

Compensation for past losses = £5878.50

Add uplift of 25% for breaches of the ACAS Code of Practice in respect of grievance procedure and disciplinary procedure = \pounds 1469.63

Total Compensation for past losses = £7348.13

Injury to Feelings

=£18,250

Add uplift of 25% for breaches of the ACAS Code of Practice in respect of grievance procedure and disciplinary procedure = \pounds 4562.50

Total compensation for injury to feelings = £22,812.50

Interest

The Tribunal did not make reference to interest when giving judgment orally. The Tribunal considers it appropriate in the circumstances of this case to award interest under regulation 2 the Employment Tribunals (Interest on Awards in Discrimination Cases) Regulations 1996.

The Tribunal awards interest on both compensation for past losses and injury to feelings as follows:

Interest on compensation for loss of earnings:

Interest rate - 8%

113/2 x 0.08 x 1/365 x £7348.13= £91

Interest on injury to feelings

Date of discriminatory act: 23 April 2021

Calculation date: 23 May 2023

Interest rate - 8%

760 days x 0.08 x 1/365 x 22,812.50 = £3800

Total interest = £3891

TOTAL AWARD = £7348.13 + £22,812.50 + £3891 = £34,051.63
