# Re: S31 Grant Determination Letter for Family Hubs and Start for Life programme P1 Revenue (2022-23): [No 31/6417]

This Determination is made between:

## (1) The Secretary of State for Education and

## (2) The local authorities listed in Annex A

We are issuing this revenue Grant under section 31 of the Local Government Act 2003. The Senior Responsible Officers for this grant, Susie Owen and Liz Ketch, will require your responsible officer to confirm at the end of the financial year that the funding has been properly expended.

## Background to the Family hubs and Start for Life programme

In October 2021, the government announced **£301.75 million for 75 uppertier local authorities in England** to deliver Start for Life and family services over 3 financial years (FY), 2022-23 to 2024-25. The money will fund a joint programme overseen by the Department for Education (DfE) and the Department of Health and Social Care (DHSC). DfE will be administering the grant funding on behalf of both departments. The funding is broken down as follows:

- £100 million for bespoke parent–infant relationship and perinatal mental health support
- £81.75 million to create a network of family hubs, improving access to a wide range of integrated support services for families with children aged 0–19 [£15 million of which is capital funding]
- £50 million to establish infant feeding support services

- £50 million to fund parenting support services
- £10 million to support local authorities to publish a clear Start for Life offer, and establish Parent and Carer Panels
- £10 million to trial innovative Start for Life workforce models. Note: this element of the funding package sits outside of the Family Hubs and Start for Life programme. It comes onstream in FY 2023/24 and will be allocated to a smaller number of local authorities (5). It is therefore not covered by this determination letter.

The programme now also includes **£28.7 million** to train practitioners to support parents with the **home learning environment**, taking the programme's total expenditure to £330.45m between 2022-23 financial year and 2024-25 financial year.

Participating local authorities will receive a share of all funding streams above, other than the £10m for workforce trials for the reasons outlined. All local authorities will be expected to deliver across all components of the programme for which they are receiving funding.

## Background and purpose of the additional trailblazer funding

14 local authorities will be given an opportunity to lead the way in delivering the programme's expectations in the first financial year (2022-23). These trailblazers will become national leaders for the Family Hubs and Start for Life programme, focusing on perinatal mental health and parent-infant relationships, infant feeding, and parenting support. They will establish best practices, make the quickest improvements to services, and support other local authorities and the Government with their delivery expertise.

For FY 2022-23, we expect the additional funds for trailblazers to be made available to local authorities in the form of a non-ringfenced grant paid in two instalments. The first payment will be made after the local authority signs up to the programme and signs a memorandum of understanding (MOU) with the DfE and once their trailblazer status has been confirmed. The second payment should be made later in the financial year after the local authority has submitted a satisfactory delivery plan - this payment will be subject to HMT approval. The two trailblazer payments made to each local authority will be of equal value, with the amounts provided reflecting the number of strands that each local authority will focus on.

Full details of the trailblazer aims and objectives and the expectations that local authorities are expected to deliver with this funding are set out in the Family Hubs and Start for Life Programme Trailblazer Guide <u>Family Hubs and Start for Life Programme - Trailblazer Guide (publishing.service.gov.uk)</u>.

### **Citation**

1) This determination may be cited as the Family Hubs and Start for Life Programme P1 Revenue Grant Determination (2022-23) [No31/6417].

#### Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them to deliver the expectations set out in the Family Hubs and Start for Life trailblazer Guide Family Hubs and Start for Life Programme - Trailblazer <u>Guide (publishing.service.gov.uk)</u> and the obligations set out in the Memorandum of Understanding (MOU) between the Secretary of State and each of the 75 local authorities to which grants are to be paid.

#### **Determination**

3) The Secretary of State determines the local authorities to which grants are to be paid and the amounts to be paid; these are set out in Annex A.

#### Treasury consent

4) Before making this determination in relation to local authorities in England, the Secretary of State obtained the consent of the Treasury.
