
This is an Easy Read version of some information. It may not include all of the information but it will tell you about the important parts.

About this supporting statement



This is an Easy Read guide for writing a **supporting statement**.

A **supporting statement** is a report written by someone who is asking for a **court order**.



A **court order** stops someone from being able to do certain things.

This supporting statement guide is for people who are asking for either/both:





1. A non-molestation order - this is a court order that will protect you and any children from **abuse** by a certain person.

Abuse is when someone hurts you or treats you badly. This is also called abusive behaviour.



2. An occupation order - this is a court order that decides who should live in your house.

How court orders work



The person who is asking for a court order against someone is called the 'applicant'.



The person who the court order is against is called the 'respondent'.



The applicant will fill in some court order documents to explain why they want a court order, including:





- A form called an 'FL401 application form' there is an Easy Read version of this.
- A supporting statement.

What happens next?



Court Order



The respondent will be told that the applicant has asked for a court order against them.

They will be given a copy of the court order documents.

They will usually be given these by the applicant's lawyer.

Respondents are told someone has made a court order against them so that they can prepare for the **court order hearing.**



The **court order hearing** is where a judge will decide whether the court order should go ahead or be changed.



'Without notice order'

A **'without notice order'** means the respondent does not know an applicant has asked for a court order against them.



You can ask for a 'without notice order' in your FL401 application form.



'Without notice orders' are only given in very special cases, like if your life is in danger.

What is a supporting statement for?



A supporting statement is a report written by an applicant.

It gives the court extra information about the abuse the applicant has dealt with.



The extra information will help the judge make a decision at the court order hearing.



If you are applying for a nonmolestation and/or an occupation order then you will need to write a supporting statement.

Supporting Statement

You can write more than 1 supporting statement if you would like.

This guide will help you.



How to write a supporting statement

You can write a supporting statement by answering questions and ticking the right boxes in this booklet.




There are 8 parts for you to fill in.



You do not have to use this booklet to write a supporting statement.

You can do it on your own if you would like to.

Exhibits



An **exhibit** is like a piece of evidence. It can be any document that supports what you have written in your supporting statement. You may want to include some exhibits in your supporting statement, like:



• Medical reports from when you or your children were harmed.




• Reports or letters from social services.



• Copies of any contact you have had with the respondent that shows their abusive behaviour, like emails, texts and social media messages.



You will need to fill in an 'exhibit coversheet' for each exhibit you want to include.



You can find the coversheet on pages 52 to 54.

Keeping your contact information secret



If you do not want the respondent to know how to contact you or your children, do not write your contact information in your supporting statement.

Sending your court order documents



You now need to send your supporting statement, and other court order documents, to your local family court.

What to send

You need to send this supporting statement with your other court order documents, including:


- Your FL401 application form.
- Any other forms the application form told you to fill in.
- A supporting witness statement.

A **supporting witness statement** is a report written by someone who can support your need to have a non-molestation or occupation order.









How to send

You can email or post your court order documents to your local family court.



You can find your local family court's email address and postal address at: <u>www.gov.uk/find-court-tribunal</u>



You can take your court order documents there in person if you cannot email or post them.



There is more information about sending your court order documents in your FL401 application form.

What happens next?



Once your local family court has your court order documents, copies of them will be given to the respondent.



This is unless a 'without notice order' is allowed.



Remember, you must not give the respondent copies of the court documents yourself.
