The TRA-inherited cloud infrastructure was created on 29<sup>th</sup> June 2018. For your information, the TRA was established on 1<sup>st</sup> June 2021.

The TRA does not hold this information.

The percentage of infrastructures employing cloud services. 100%

The supplier of cloud infrastructures used (AWS/Oracle/Azure etc.).

Microsoft O365. Azure and Amazon Web Services.
