# Monthly Summary

- 1.1.1 This Summary Report is published in fulfilment of commitments detailed in the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, Annex 1: Code of Construction Practice, for the nominated undertaker to present the results of air quality and dust monitoring undertaken in the London Borough of Ealing (LBE) during April 2023 and May 2023 respectively.

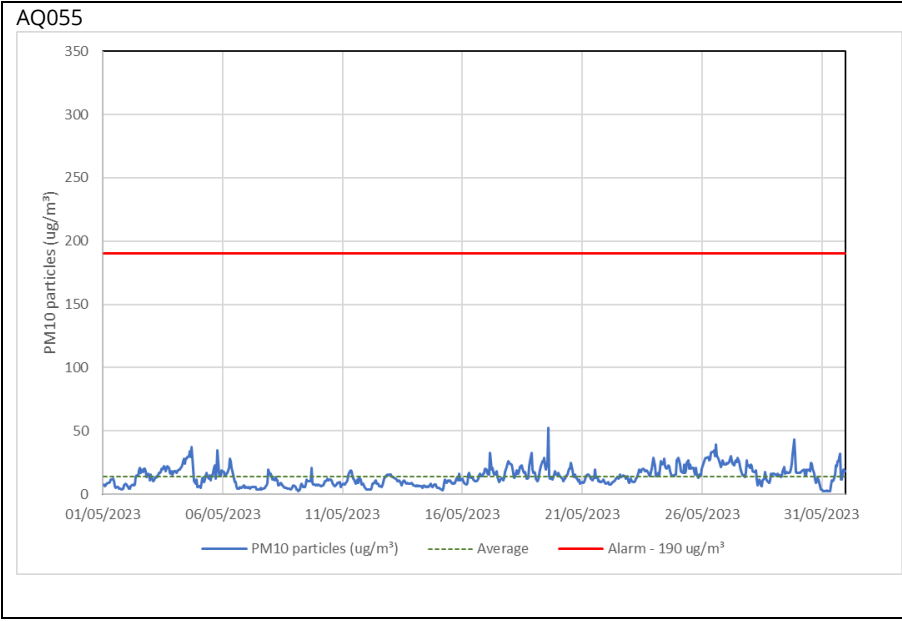
Figure 3: Construction dust 1-hour mean indicative PM<sub>10</sub> concentration for dust monitors

- 1.1.2 Figure 1 to Figure 3 in Appendix A indicate the current worksites together with air quality and dust monitoring locations.
- 1.1.3 This summary should be read in conjunction with the overview monitoring report available from [www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2](http://www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2), which highlights: the applicable standards and guidance, as well as the air quality and dust monitoring methodologies to be implemented by nominated undertakers throughout construction.
- 1.1.4 The current phase of works commenced in October 2019 and is expected to be completed by 2025. The current worksites, as presented in Appendix A, Figure 1 to Figure 3, include:

## **Scheme 6**

- Signalling and Telecommunication works;
- Civil works;
- Overhead line equipment works; and
- Electrification and plant works.

## **Old Oak Common Depot (located in the London Borough of Hammersmith and Fulham)**

- General Site - Concrete Works, Drainage and Kerb Installation;
- Station Box - Concrete, D-Wall breakdown, steel fixing and excavation;
- UTPZ / CRL Retaining Wall - RC works, Backfill, Concrete cutting, Black jacking and Formwork construction;
- Shared Accommodation Building - Plank Installation;
- Site haul roads and public roads adjacent to site - cleaning with a road sweeper;
- Great Western Main Line / Central Box – Piling Platform works and demobilisation;
- OOCL - Great Western Main Line / Removal of Wycombe Line Bridge; and
- Satellite Sites / Central Line east - OOC Pile mat construction , Piling and Slit trench excavation.

## **Victoria Road Crossover Box and Flat Iron Site**

- Groundworks;
- Piling operations shaft construction; and

- Conveyor construction.

#### **Willesden Euro Terminal**

- Excavated material spoil management; and
- Conveyor construction.

#### **Atlas Road**

- Piling operations;
- Groundworks;
- Conveyor construction; and
- Tunnel entrance construction.

#### **Green Park Way Vent Shaft**

- Groundworks;
- Piling operations;
- Vent shaft construction; and
- Materials management.

#### **Mandeville Road Vent Shaft**

#### **Westgate Vent Shaft**

- Groundworks;
- Piling operations;

1.1.5 Seventeen (17) dust monitors were installed around worksites, where works are underway. These sites returned a medium dust risk rating.

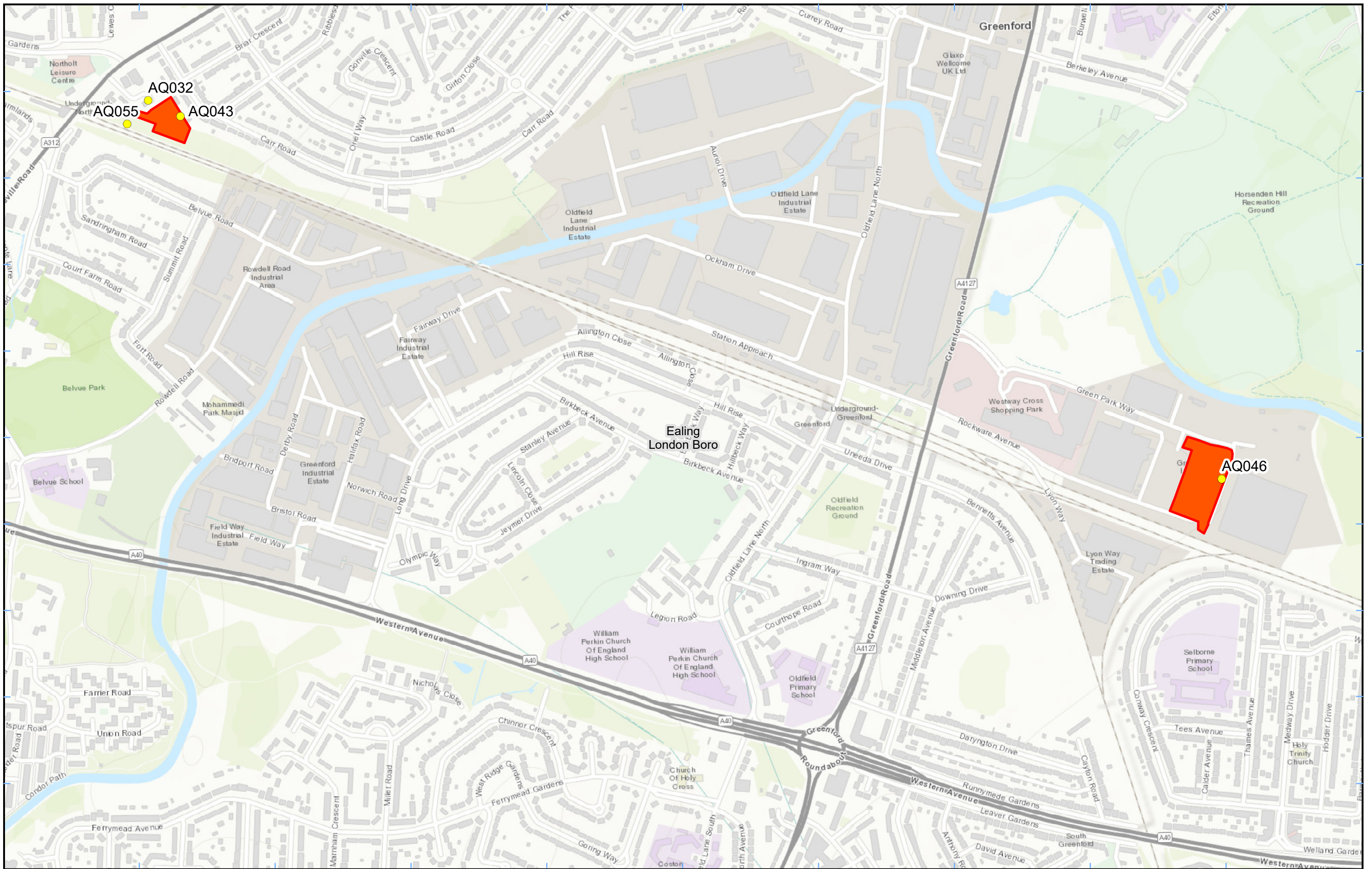
1.1.6 Dust monitoring locations and results are presented in Appendix B, Table 2, together with line charts of monthly data from each dust monitor, Figure 4. All continuous dust monitoring is undertaken using indicative monitors. Despite being Environment Agency (MCERTS) certified, indicative monitors carry a higher level of uncertainty than reference monitors, and therefore cannot be strictly compared with Air Quality Standards for human health and the environment. The purpose of the monitoring undertaken is to ensure the effectiveness of the on-site mitigation.

1.1.7 The trigger level for PM<sub>10</sub> concentrations of 190 µg/m<sup>3</sup>, over a 1-hour period, in accordance with the updated guidance document '*Guidance on Monitoring in the Vicinity of Demolition and Construction Sites – (October 2018)*' has been applied.

- 1.1.8 Dust trigger alerts were recorded during the monitoring period (May 2023) and are reported in Appendix B, Table 2.
- 1.1.9 Data capture was below 90% for multiple monitors in May 2023 due to monitor faults that have since been resolved, and works in the area requiring temporary disconnection.
- 1.1.10 Diffusion tube monitoring of Nitrogen Dioxide (NO<sub>2</sub>) is undertaken at six (6) locations around highways within the LBE as part of the management of air quality where significant effects may occur as a result of the scheme.
- 1.1.11 Diffusion tube monitoring results are as provided from the laboratory analysis, and therefore still require various analysis and adjustments to be undertaken. Final corrected results will be presented and described in the annual report. However, based on the results to date, no unexpected values were recorded during the monitoring period.
- 1.1.12 NO<sub>2</sub> monitoring locations and results are presented in Appendix C, Table 3, together with the 2023 running mean.
- 1.1.13 There were no (0) complaints received during this reporting period (May 2023).

Figure 1 to Figure 3: Worksites and monitoring locations within the LBE



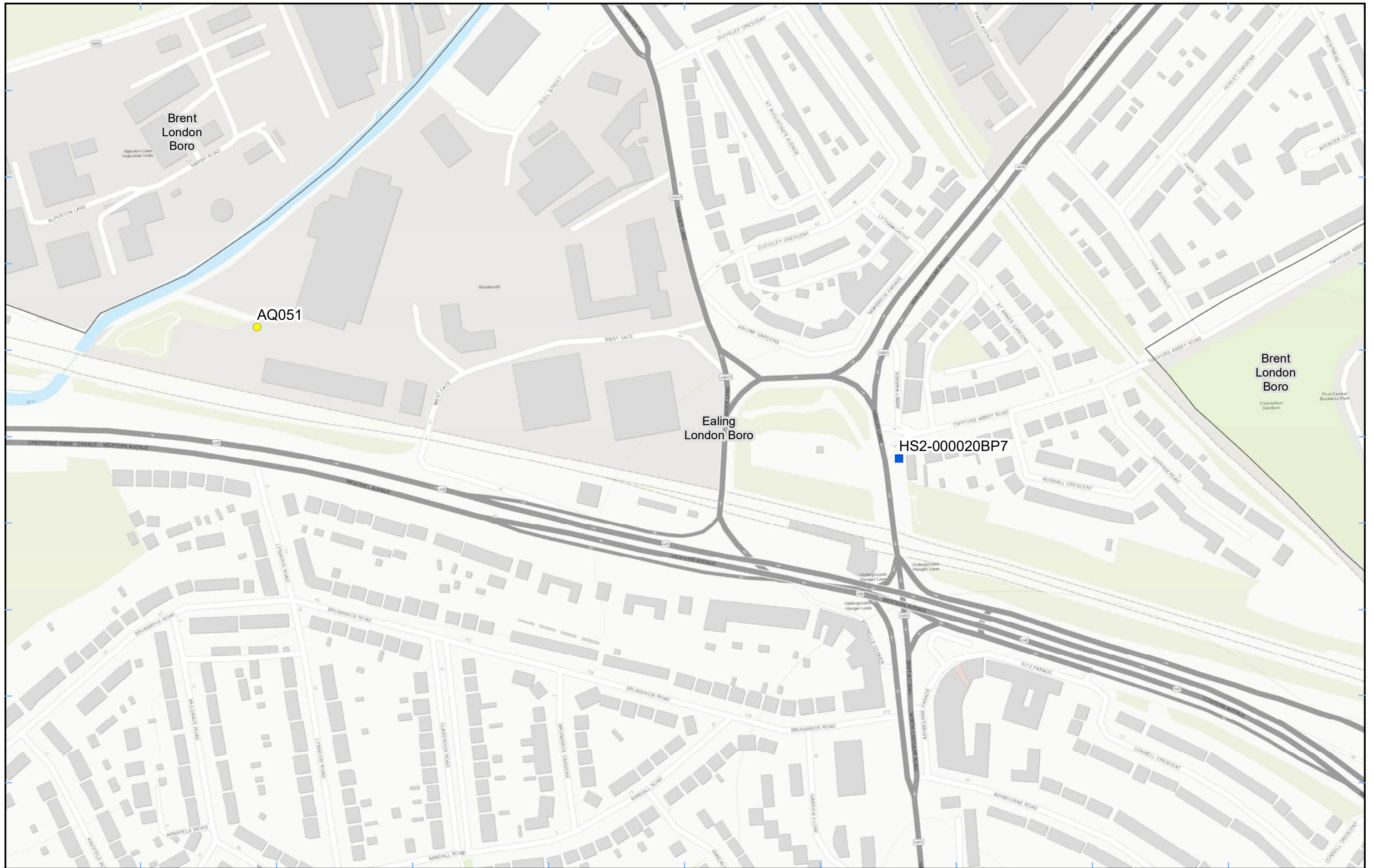

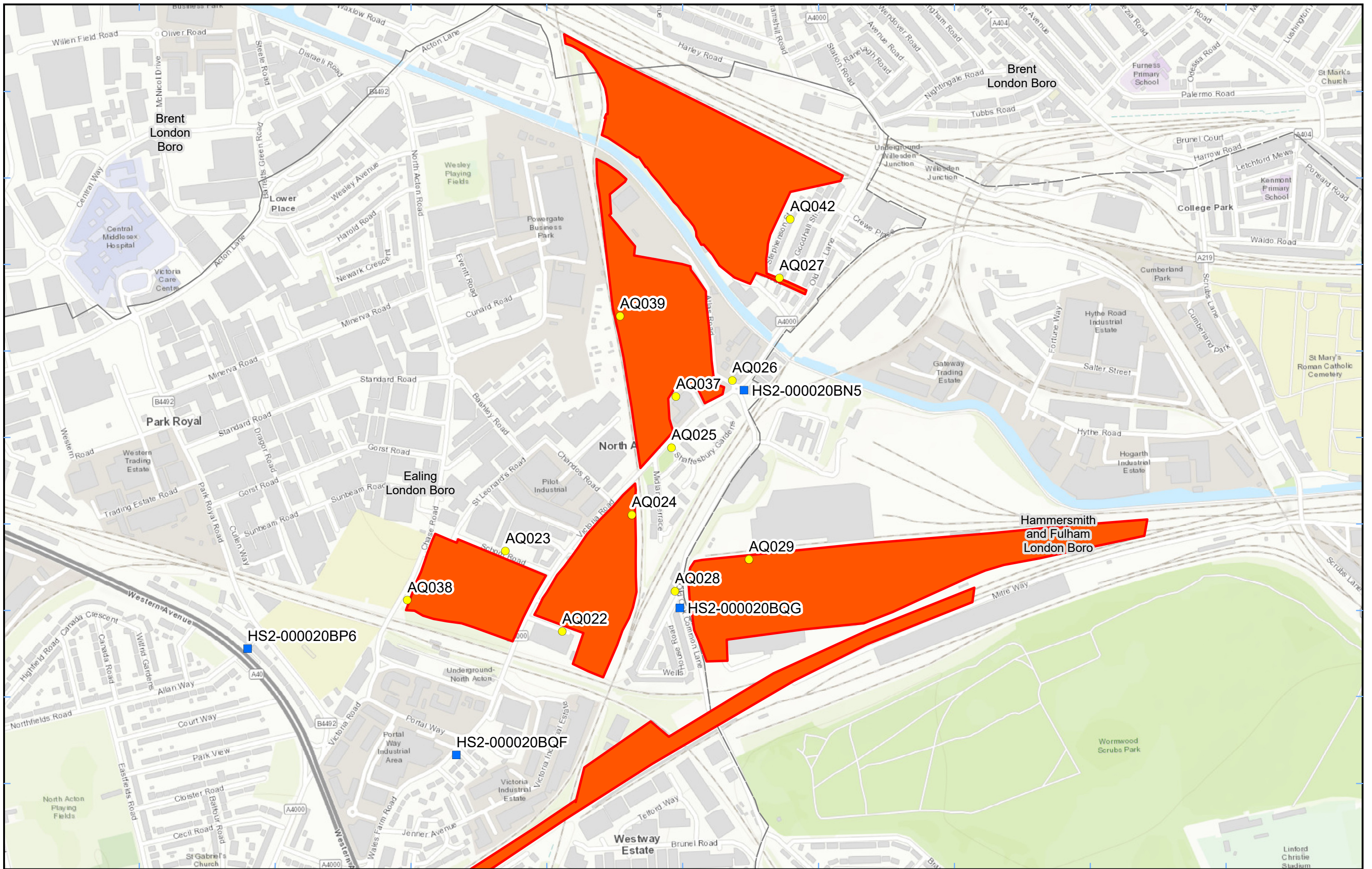
