



### Why you are being served this PCN

You are the registered keeper or person liable for the vehicle in the photos. You are being served this PCN because payment was not made for the vehicle by midnight the day after the crossing.

## What you need to pay

**Date of service:** The date of service is when this letter is effective from. Your date of service is the second working day after 11 August 2022.

If you do not pay or challenge this PCN within 28 days from the date of service, a charge certificate will be issued. This will increase the penalty charge to £105.00.

The grounds (reasons) below are defined by the Road User Charging Schemes (Penalty Charges, Adjudication and Enforcement) (England) Regulations 2013. If none of the reasons apply, you can still challenge this PCN but you must provide a compelling reason with evidence.

If we reject your representation, you will receive a written notice of rejection telling you how to appeal against that decision to the independent adjudicator at the Traffic Penalty Tribunal (TPT).

G	rounds for representation	What information you need to provide
Α	You were not the registered keeper of this vehicle	Name and address of the person who was the registered keeper at the time of the crossing. If sold, provide proof of sale.
В	The vehicle was used without your consent	For instance, if the vehicle had been stolen provide a crime reference number.
С	The vehicle was hired to someone at the time	Copy of the hire agreement and the statement of liability to show the driver was aware of their responsibility for road charges.
D	You paid the road user charge on time	Receipt or payment reference number. If you cross a lot, provide details for the crossing you received the PCN for.
E	No road user charge or penalty charge is payable under the charging scheme	If there's no charge for your vehicle, provide the vehicle log book (V5C form) to show the vehicle class. For an emergency service or military vehicle, include a letter from an appropriate officer.
F	The penalty charge exceeded the amount applicable in the circumstances of this case	If you think you've been charged more than you should have been, provide evidence of what you were charged and what you should have been charged.
G	Procedural impropriety by charging authority	Dart Charge did not follow its own rules in issuing the PCN. If this happened, provide evidence of which rules were broken.
