What will happen if you do not pay

If you do not pay within 14 days from the date of service, we will take steps to recover the debt including:

- registering the debt at the County Court (you will have to pay an additional charge for this)
- requesting a court order be issued against you (this is not a County Court Judgment)
- getting Enforcement Agents to collect the outstanding debt, if the court order remains unpaid
- asking Enforcement Agents to take control of your vehicle or goods from your property

Paying for future crossings

To avoid future PCNs, you need to pay for crossings by midnight on the day after you cross. You can set up an account or apply for local resident discount at: gov.uk/dart-charge
