### PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about the movement assistance scheme, which the Animal and Plant Health Agency (APHA) received on 16 February 2023. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"My request relates to the operation of the movement assistance scheme.

#### I seek:

Details from the database or similar data source connected to payments made under the Movement Assistance Scheme, the scheme in place to help with the movement of agri goods to Northern Ireland. I am happy to refine this to claims related to equines - if it is possible to filter the results on this basis. If not, I would like the entire database.

The information I seek is a database extract of all payments made under the scheme since its inception. This should include the amount, date, nature of recipient (trader / certifier), Unique support attestation number, Export Health Certificate classification number (eg 8431, 8432, 8433 or 8434), Exporter, Type of attestation, claim authorising office, destination and recipient.

If the database does not capture these fields or they are held in multiple tables please advise on what information is readily accessible or available through database queries or multiple table exports. If any fields are not kept this should not preclude the release of fields that are kept. I am happy to discuss this."

APHA has a centralised finance team so the claims for payment are dealt with by a single team. The final destination and recipient is not held by APHA.

Under the Movement Assistance Scheme (MAS), APHA has verified and paid 4,697 Equine Export Health Certificates (EHCs) totalling £1,434,364.95.

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

Below is the number of EHC types which have been verified and paid for each year.

APHA consider that disclosure of this information is likely to breach the first data protection principle, which provides that personal data must be processed lawfully, fairly, and in a transparent manner. Disclosure would not constitute 'fair' processing of the personal data because the information would lead to the identification of persons other than the requester.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
