PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about National Housing Orders for Avian Influenza, which the Animal and Plant Health Agency (APHA) received on 7 March 2023. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"I am looking for the start and end dates of each national Housing Order issued by the UK and devolved governments, mandating the housing of poultry due to Avian Influenza risk, between and including the years 2015 - 2022.

I am *not* looking to include the regional housing orders; only those applying to the whole of the UK or any combinations of its devolved regions of England, Scotland, Wales or Northern Ireland."

Please note that animal health is a devolved matter and separate Avian Influenza Prevention Zone (AIPZ) declarations are made in each administration.

Between 2015 and 2022 mandatory housing measures have been utilised as a requirement of a national AIPZs during the following time periods:

- o England
 - 6 December 2016 to 15 May 2017
 - 14 December 2020 to 31 March 2021
 - 29 November 2021 to 2 May 2022
 - 7 November 2022 to present (i.e. still in force)
- o Wales
 - 6 December 2016 to 1 May 2017
 - 14 December 2020 to 31 March 2021
 - 29 November 2021 to 2 May 2022
 - 2 December 2022 to present (i.e. still in force)
- o Scotland
 - 6 December 2016 to 1 May 2017
 - 29 November 2021 to 2 May 2022

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

- 14 December 2020 to 31 March 2021
- Northern Ireland
 - 23 December 2016 to 31 May 2017
 - 23 December 2020 to 14 April 2021
 - 29 November 2021 to 2 May 2022
 - 28 November 2022 to present (i.e. still in force)

The prevention measures introduced through the AIPZ, including addition of mandatory housing measures, are introduced in a phased and escalating manner proportionate to the escalating risk to an area and have been utilised on both a regional or national basis depending on the epidemiological situation.

In addition, during confirmed avian influenza outbreaks, housing measures are routinely applied to poultry and other captive birds within a Protection Zone This is a 3km zone put in place by the government around infected premises, where highly pathogenic avian influenza has been confirmed, to prevent further spread of the disease.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
