STATEMENT TO MEMBERS ISSUED IN CONNECTION WITH THE UNION'S ANNUAL RETURN FOR THE PERIOD ENDED 31ST DECEMBER 2022 AS REQUIRED BY SECTION 32A OF TRADE UNION AND LABOUR RELATIONS (CONSOLIDATION) ACT 1992

Income and expenditure

The total income of the union for the period was £146,865,000 This amount included payments of £52,217,000 in respect of membership of the union. The union's total expenditure for the period was £164,844,000. The union does not maintain a political fund.

Salary paid to the Chair of Council, Treasurer and Chair of RB

The Chair of Council was elected 30th June 2022 and was paid £65,785 in respect of trade union activities for the period 30th June to 31st December 2022. This represents 67.49% of their gross salary of £97,476 for the same period. BMA has paid the employer's Nation insurance contributions of £9,251 attributable to the trade union activities.

The previous Chair of Council demitted office on the 30th June 2022 and was paid £93,250 in respect of trade union activities for the period 1st January 2022 to 30th June 2022. BMA has paid the employer's Nation insurance contributions of £12,713 attributable to the trade union activities.

The Treasurer was paid £34,046 in respect of trade union activities. This represent 34.68% of their gross annual salary of £98,168. BMA has paid the employer's National Insurance contributions of £2,043 and a pension contribution of £3,504 attributable to the trade union activities.

The Chair of RB was paid £63,906 in respect of trade union activities. This represents 66.15% of their gross annual salary of £96,613. BMA has paid the employer's National Insurance contributions of £7,657 and a pension contribution of £3,834 attributable to the trade union activities.

Irregularity statement

A member who is concerned that some irregularity may be occurring, or have occurred, in the conduct of the financial affairs of the union may take steps with a view to investigating further, obtaining clarification and, if necessary, securing regularisation of that conduct.

The member may raise any such concern with such one or more of the following as it seems appropriate to raise it with: the officials of the union, the auditor or auditors of the union, the Certification Officer (who is an independent officer appointed by the Secretary of State) and the police.

Where a member believes that the financial affairs of the union have been or are being conducted in breach of the law or in breach of the rules of the union and contemplates bringing civil proceedings against the union or responsible officials they should consider obtaining independent legal advice.
