JUDGMENT

The claims are struck out under rule 37 of the Rules contained in Schedule 1 of the Employment Tribunals (Constitution and Rules of Procedure) Regulations 2013 on the grounds that the claims have not been actively pursued in terms of rule 37(1)(d).

REASONS

1. On 14 February 2023, claimants' representative wrote to the Tribunal to confirm that they had withdrawn from acting on behalf of the claimants detailed

in the schedule attached to this Judgment. The Tribunal wrote to those claimants on 24 March 2023 and asked them to confirm the current position of their case by no later than 12 April 2023. No reply was received.

- 2. On 24 April 2023, the Tribunal gave the claimants an opportunity to give written reasons by 8 May 2023 or to request a hearing in order to consider why the claims should not be struck out.
- 3. The claimants have failed to give an acceptable reason why such a judgment should not be made or to request a hearing. The Tribunal therefore strikes out the claims.
