PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about inspections of fish slaughterhouses, which the Animal and Plant Health Agency (APHA) received on 10 January 2023. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"How many inspections at fish slaughterhouses in Scotland have been carried out by APHA Scotland since 24th August 2022?"

Three.

"Please provide inspection reports from all the inspections at fish slaughterhouses carried out by APHA Scotland since 24th August 2022."

The information requested can be found at Appendix 1-3.

"Please confirm if these inspections include fish who are killed on wellboats / slaughterboats."

These are land based harvesting sites.

"If so, please provide the number of inspections that were carried out specifically on wellboats / slaughterboats"

No inspections were carried out on wellboats / slaughter boats by APHA.

"Please also provide the following information from the inspections at fish slaughterhouses carried out by APHA Scotland since 24th August 2022: The number of illegalities witnessed"

No non-compliances with the applicable legislation were found at time of inspection.

"How often will the inspections carried out by APHA Scotland that started on 1st February 2022 be carried out at all fish slaughterhouses in Scotland? E.g. annually/other frequency."

This will be decided by Scottish Government's Animal Welfare Policy Team on a risk based approach following inspections.

Section 40 – Personal Information

APHA have decided some of the information held within Appendix 1-3 should be withheld under Section 40(2) and 40 (3A) of the FOIA as the information constitutes personal data relating to persons other than you.

These sections exempt personal information from disclosure if that information would breach any of the data protection principles in Article 5(1) of the General Data Protection Regulations (GDPR).

APHA consider the disclosure of the redacted information is likely to breach the first data protection principle, which provides that personal data must be processed lawfully, fairly and in a transparent manner. Disclosure of 3rd party information (names and number of employees) would not constitute 'fair' processing of the personal data because it could lead to the identification of third parties.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
