- Enterobacteriaceae: n=5, c=2, m=10, M=5000 in 1 gram

(2) animal by-product or derived product obtained from bovine, ovine or caprine animals which have been killed, after stunning, by laceration of the central nervous tissue by means of an elongated rod-shaped instrument introduced into the cranial cavity, or by means of gas injected into the cranial cavity, except for those animals that were born, continuously reared and slaughtered in a country or region classified as posing a negligible BSE risk as set out in a document relating to 'BSE risk status' published on GOV.UK, in accordance with Regulation (EC) No 999/2001<sup>(‡)</sup>. <sup>(†)</sup>The document(s) referred to above can be found at:
