The colostrum/colostrum products must have been produced from colostrum derived from animals which at the time of milking did not show clinical signs of any disease transmissible through colostrum to humans or animals, and which had been kept for a period of at least 30 days prior to the date of production on holdings that were not subject to official restrictions due to foot-and-mouth disease or rinderpest.

AH/P005 Product requirements (segregation)

 - the condition that the colostrum or colostrum products have been produced during a period at least 21 days before the date of shipping and during this period no cases of FMD have been detected in the exporting country;
 - **OR** the condition that the colostrum or colostrum products have been produced, in consideration of the foreseen voyage duration, on a date at least 21 days before the consignment is presented to a border control post of the point of entry into Great Britain.
- **(b)** Officially tuberculosis-free and brucellosis-free herds are as laid down in Annex A to Council Directive 64/432/EEC and officially enzootic-bovine-leukosis-free herd as laid down in Chapter I of Annex D to that Directive.
