On behalf of Stansted Airport Limited (STAL), please find enclosed the submission of a planning application pursuant to Section 62a of the Town and Country Planning Act 1990 (as amended) for the partial demolition of the existing Track Transit System and full demolition of 2 no. skylink walkways and the bus-gate building, and the construction of a 3-bay extension to the existing passenger terminal, baggage handling building, a plant enclosure and 3 no. skylink walkways and associated hardstanding.

Planning Application Fee

We have calculated the planning application fee in accordance with the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012 (as amended).

The development falls within the category 'erection of buildings (not dwellinghouses, agricultural, glasshouses, plant nor machinery)' and therefore, for development of more than 3,750 square metres it attracts the fee of £22,859 + £138 for each additional 75 square metres (or part thereof) in excess of 3,750 square metres.

We calculate the fee for the gross floor area of 52,445sqm as £112,187, reached as follows:

- £22,859 + (£138 x 649.3) = £112,187
- The 649.3 was reached by (52,445-3,750) / 75 = 649.3.
