- (a) the bumble bees (*Bombus* spp.) referred to in Part I of this certificate have been bred and kept under a controlled environment within a recognised establishment which is supervised and controlled by the competent authority;
- (b) the establishment referred to in Part I of this certificate was inspected immediately prior to dispatch and all bumble bees and breeding stock show no clinical signs or suspicion of disease including infestations affecting bees; and
- (c) all colonies for import into Great Britain have undergone detailed examination to ensure that all bumble bees, broodstock and packaging do not contain the small hive beetle (*Aethina tumida*) or its eggs and larvae or other infestations in particular *Tropilaelaps* spp., affecting bees;
