Converter Academy Orders

Points discussed in relation to school conversion.

Project: To discuss Berry Brow Infant and Nursery School, Huddersfield, to convert and join Impact Education Multi Academy Trust.

AB Discussion:

- Berry Brow Infant and Nursey School and Newsome Junior School have chosen to voluntarily convert to become academies and join Impact Education MAT, with a proposal for both schools to convert simultaneously. The schools are informally federated, sharing the same Governing Body and Headteacher, with the Headteacher splitting their time between both schools. Berry Brow is a feeder school for Newsome Junior School.
- Although Berry Brow was judged to be Good at its last section 5 inspection in 2016, the most recent section 8 inspection (2022) indicates the school may not maintain this good judgement. The school recognises there are improvements to be made and welcomes the support of an established MAT. The school has therefore sought to identify and join a MAT that can provide support, advice and guidance to their school improvement journey.
- It was noted that the Trust is currently in a deficit financial position. Schools Financial Support and Oversight (SFSO) colleagues recommended that prior to conversion, the Trust must agree to a viable recovery plan. To facilitate this, the trustees must meet monthly and provide monthly Management Accounts to the Department. A School Resource Management Advisor (SRMA) has been deployed to the Trust.
- The performance of the Trust's existing primary schools was discussed. Whilst it was noted that some of the schools were below national average, it was considered that sufficient progress was being made.
- AB members were supportive of the project, subject to the financial recovery plan.

RD decision: Approve with conditions

Conflicts: Kash Rafiq was not present and did not receive papers for this item.

- SFSO to agree viable recovery plan to conversion. To aid this, the trust must provide monthly management accounts to track recovery and hold monthly finance meetings to facilitate / evidence the above.

Project: To discuss Newsome Junior School, Huddersfield, to convert and join Impact Education Multi Academy Trust.

AB Discussion:

- Berry Brow Infant and Nursey School and Newsome Junior School have chosen to voluntarily convert to become academies and join Impact Education MAT, with a proposal for both schools to convert simultaneously. The schools are informally federated, sharing the same Governing Body and Headteacher, with the Headteacher splitting their time between both schools. Berry Brow is a feeder school for Newsome Junior School.
- The school was judged Requires Improvement at its last full inspection in 2019 and has had two monitoring visits since (March 2021 - virtual; July 2021). The most recent of these indicating that 'leaders and those responsible for governance are taking effective action in order for the school to become a good school'. Overall, this indicates an upward trajectory, but the school acknowledges there is work to do to secure a firm 'Good' judgement or above at their next inspection. As such, they have sought to find a trust that can provide support, advice and guidance on their journey to Good.
- It was noted that the Trust is in a deficit financial position currently. SFSO colleagues recommended that prior to conversion, the Trust must agree to a viable recovery plan. To facilitate this, the trustees must meet monthly and provide monthly Management Accounts to the Department. A School Resource Management Advisor (SRMA) has been deployed to the Trust.
- The performance of the Trust's existing primary schools was discussed. Whilst it was noted that some of the schools were below national average, it was considered that sufficient progress was being made.
- AB members were supportive of the project, subject to the financial recovery plan.

Project: To discuss Heptonstall Junior Infant and Nursery School, Calderdale, to convert and join The Family of Learning Trust

AB Discussion:

- This item was first discussed at the Yorkshire and Humber Advisory Board in June 2023 alongside the proposal for Shirley Manor Primary School (Shirley Manor Academy) joining The Family of Learning Trust. It was brought back to the July 2023 Advisory Board as the issues raised in June have now been addressed.
- The Delivery Officer confirmed that the Trust School Improvement Lead would provide leadership support to the school, having previously led the Trust's Dean Field school from an Inadequate Ofsted judgement to Good in 2022. Board members recommended that the Trust engage with CEO and CFO mentoring with experienced leaders.
- A revised budget for the school has been provided to SFSO colleagues. The Board considered the Trust's financial forecasts in light of current pressures on budgets and a School Resource Management Advisor (SRMA) was recommended.

Project: To discuss The Hub School, Hull, to convert and join The Education Alliance

AB Discussion:

- The Hub School is a school which offers specialist support for pupils with SEMH needs. The school aims to improve the life chances of pupils for whom mainstream education has not been successful. Pupils attending the school are provided with an alternative education experience in a nurturing, safe and supportive environment.
- The school is at full capacity with 147 pupils and a further 20 pupils in short term PRU provision at the school's Welton site, which is a temporary arrangement. The Board recognised the need for early succession plans for the children currently using the Welton sight.
- The Trust plans to get specialist experience through their strong strategic partnership with Wellspring Academy Trust. The Education Alliance is considered to be a good fit geographically and has the required resources to support the school.

AB Discussion:

- This item was considered alongside that of Bramley Sunnyside Junior School joining the same trust.
- Parson Cross CofE Primary School (PC) is seeking approval to convert to academy status and join The James Montgomery Academies Trust (JMAT). PC is a Church of England Voluntary Aided Primary School in the Diocese of Sheffield.
- The Diocese is supportive of the project and of JMAT moving into Sheffield Local Authority area. The school believes they would benefit from joining a Trust of JMAT's size and capacity.

Project: To discuss Bramley Sunnyside Junior School, Rotherham, to convert and join James Montgomery Academy Trust.

AB Discussion:

- This item was considered alongside that of Parson Cross Church of England Primary School joining the same trust.
- Bramley Sunnyside (BS) Junior School is a local authority maintained primary school in Rotherham, providing education for children aged 7 to 11 years. After conducting due diligence, BS established a working relationship with JMAT in November 2022.
- The school believes they would benefit from joining a Trust of JMAT's size and capacity.

Points discussed in relation to the Sponsored Route

Project: To discuss Little London Primary School, Leeds, to convert and join The GORSE Academies Trust.

AB Discussion:

- Little London Primary School is a 4-11 community school located in Woodhouse, Leeds. The Board recognised that this was a school in need of both school improvement and financial support.
- There is an existing relationship which would be strengthened through this conversion. It was considered that The GORSE Academies Trust (TGAT) has sufficient capacity and expertise to provide the support the school requires.
- The Board noted that the percentage of pupils with Education and Health Care Plans was below the National Average but was assured that this was due to the approach taken in assessing needs by Leeds Local Authority. It was also noted that the percentage of pupils entering the English Baccalaureate was below National Average.

Project: To discuss Northfield Primary School, Pontefract, to convert and join Pontefract Academy Trust.

AB Discussion:

- Northfield Primary School is a maintained primary school in the South Kirkby district of Wakefield.
- Board members noted that the school needs support to improve its pupils' performance at Key Stage 2, and this was a particular strength of the Trust.
- Projected pupil numbers were discussed, and the Delivery Officer confirmed that there are no concerns over the long term viability of the school. The school will be at capacity moving forwards but there is a surplus of places in Wakefield as a whole. The finances show a positive trend and the trust has healthy financial forecasts.
- The Board recommended further members be recruited to the Trust Board.

AB Discussion:

- This item was considered together with Eastborough Junior Infant and Nursery School converting and joining the same trust.
- The Local Authority is supportive of the 2 schools joining Delta Academies Trust and Board members agreed this represented a good match.
- The Advisory Board commented on the generally strong outcomes of the trust but noted several of their schools have below average results for Key Stage 2. The Trust is considered to have sufficient primary expertise to secure improvements in its schools.
- An email representation was received from another Trust expressing interest in taking on Heckmondwike Primary School and shared verbally with the Board. It was noted that whilst there were other viable options locally, Delta is considered to have the appropriate capacity and expertise to support the school.
- The current membership of the Trust Board was discussed. Advisory Board members would encourage more diversity on the Board, where possible.

- The Local Authority is supportive of the 2 schools joining Delta Academies Trust and Board Members agreed this represented a good match.
- The Advisory Board commented on the generally strong outcomes of the trust but noted several of their schools have below average results for Key Stage 2. The Trust is considered to have sufficient primary expertise to secure improvements in its schools.
- The current membership of the Trust Board was discussed. Advisory Board Members would encourage more diversity on the Board where possible.

Points discussed in relation to academies moving to another trust.

Project: To discuss Whitehill Academy, Halifax, (I-trust - to dissolve trust) joining Trinity Multi Academy Trust.

AB Discussion:

- Whitehill Community Academy (WCA) is an academy for 3-11 year olds located in Halifax, Calderdale. The school is a 3 form entry (FE) and was the founding school of the two-school MAT, I-trust Education, when the school converted to an academy in 2011. The second school is Wainstalls School, who joined the trust in 2013 and is a 1FE primary located in the rural village of Wainstalls, Calderdale.
- I-trust has lacked permanent leadership since the former Chair of the Trust stepped down in 2019. The Chair of Governors from Wainstalls was appointed as the interim Chair of the trust in October of that year. The school was subsequently judged 'Good' in January 2020.
- 17 emails of representations from parents raising concerns about the transfer were received and shared with the Board. There has been some friction between stakeholders such as the LGBs, trustees, members and staff. Over the past six months Regions Group has worked with the trust to minimise the disruption. More stakeholder interactions have started to take place since the summer term to support the school with the proposed transfer. Stakeholder management will remain critical to ensure that relationships between the school and incoming trust can flourish. The Delivery Officer took away an action to confirm the Diocese's view of the project.
- School's Financial Support and Oversight (SFSO) talked about the current and projected financial situation and confirmed that they didn't see a significant risk to the trust.
