PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about avian influenza data, which the Animal and Plant Health Agency (APHA) received on 11 April 2023. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"In light of the ongoing restrictions relating to the current outbreak of avian flu could you provide me with the following information if available;

1. In relation to monitoring and assessment what methodology is being used to determine avian flu infection, eg PCR tests, lab based assessment etc.

APHA can confirm that:

lab based assessment, including real-time PCR tests,

virus isolation in embryonated fowls' eggs,

haemagglutination inhibition tests to look for antibody to H5 and H7 (denoting past exposure to AI),

whole genome sequencing,

and post-mortem examination is being used to determine avian flu infection.

2. Where PCR tests are the method used for determination of infection could you provide details of the cycle rate being used or recommended for use by DEFRA.

For all the avian influenza PCR tests run during the outbreak, positive/negative status of the test sample is determined by the appearance (positive) or absence (negative) of a signal by PCR cycle number 36. This value has been determined through extensive validation of each PCR test against panels of positive and negative reference samples.

3. With regards to positive identification of avian flu within the captive bird populations can you confirm the number of birds positively confirmed to have had

avian flu as apposed to those the number euthanised due to the presence of 1 or more infected birds?"
