A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

Ministry of Defence Police (MDP) MODNet users have the capability to print to all printers on the MODNet estate. MDP do not have access to that global detail or specific detail on the number of printers on each MOD site where MDP operate as these are under the control of Defence Digital.
