I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOI Act).

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that information in scope of your request is held. This is attached, as follows:

Some of the information within Annex A falls entirely within the scope of the absolute exemption provided for at Section 40 (Personal Information) of the Freedom of Information Act and has been redacted. Section 40(2) has been applied in order to protect personal information as governed by the General Data Protection Regulations (GDPR). Section 40 is an absolute exemption and there is no requirement to consider the public interest in deciding to withhold the information.

Under Section 16 (Advice and Assistance) of the FOI Act, I can confirm that the MOD does not hold copies of the Bedford Jumbo Microfiche referred to within Annex A.
