**Project:** To discuss issuing an Academy Order to Paganel Primary School, Birmingham, to convert and become an academy and join drb Ignite Multi Academy Trust, Birmingham.

# AB discussion:

- Paganel Primary School, Birmingham is an Ofsted "Good" school who have requested to convert and join a Multi Academy Trust to bring about effective school improvement for underserved children and communities.
- drb Ignite Multi Academy Trust consists of 9 academies across Birmingham and Dudley.
- The school is collaborating with the Trust to develop the curriculum offer, inclusion and the quality of education. The school is currently utilising the Trust's central infrastructure such as finance and HR support.
- The board discussed the school's data and governance.
- The board supported the recommendation.

- Ofsted reports for Leigh's academies confirm that the trust has strengths in the areas for improvement identified at Bentley West. Feedback indicates that this initial engagement with the school has been positive and will rapidly create the right environment for improvement.

- The trust has an existing relationship with the trust having offered TSI support to the school.

- There is an existing relationship between the school and TEFAT has already worked with Rowley Hall Primary School in school improvement. They also have a shared culture and ethos.
- The board discussed the West Midlands Hubs.
- The board supported the recommendation.

- Youth Engagement Schools Trust consists of 4 academies across Cheshire East and Shropshire, with one due to open in September 2024.
- YEST has already been supporting Midpoint through ESIF and their support has had a tangible impact.
- The board sought assurances on Trust capacity.
- The board supported the recommendation.

**Project:** To discuss a reserved provision of 30 places at Tile Cross Academy.

# AB discussion:

- Tile Cross Academy, Birmingham, is an Ofsted rated 'Requires Improvement' from October 2021. The Academy wish to establish a reserved provision of 30 places for students with a designated Special Educational Need of Cognition and Learning.
- The trust has already developed expertise in running SEND Resource Bases at two of its other schools.
- This provision would help to meet demand within the city and in the local area, supporting vulnerable children to access specialist provision close to where they live.
- The board sought assurances around transparency.
- The board supported the recommendation.

**Project:** To discuss an Autistic Specialist Resource Base for 16 children at Heathfield Primary School, Birmingham.

# AB discussion:

- Heathfield Primary School, Birmingham is an Ofsted rated 'Good' from June 2018. The Academy wish to create an Autistic Specialist Resource Base from 1st September 2023 to cater for 16 children in EYFS/KS1 and KS2 groups.
- Recent Pupil Place Planning engagement has confirmed that this planned project forms a key element of the LA's plan to meet community needs.
- Birmingham City Council's SEND & inclusion strategy includes a commitment to establish more resource provision in mainstream settings providing a bridge between mainstream and specialist provision. There is currently a shortage of primary ASD resource provision in the local area.
- The board discussed capacity and transparency.
- The board supported the recommendation.

**Project:** To discuss an Autistic Specialist Resource Base for 24 children at Highfield Junior and Infant School, Birmingham.

# AB discussion:

- Highfield Junior and Infant School, Birmingham is an Ofsted rated 'Good' from January 2019. The Academy wish to create an Autistic Specialist Resource Base from 1st September 2023 to cater for 24 children in EYFS/KS1 and KS2 groups.
- Highfield Primary will undergo small scale internal reconfiguration including improving sensory rooms/areas and development of the outside areas to support the curriculum development and ensure safety.
- Recent Pupil Place Planning engagement has confirmed that this planned project forms a key element of the LA's plan to meet community needs.
- Birmingham City Council's SEND & inclusion strategy includes a commitment to establish more resource provision in mainstream settings providing a bridge between mainstream and specialist provision. There is currently a shortage of primary ASD resource provision in the local area.
- The board discussed capacity and transparency.
- The board supported the recommendation.

**Project:** To discuss an Autistic Specialist Resource Base for 20 children at Sutton Park Primary, Birmingham.

- Sutton Park Primary, Birmingham has not received an Ofsted inspection since joining the trust. The previous school (Banners Gate Primary School) was inspected in June 2018 and judged Inadequate. The Academy wish to create an Autistic Specialist Resource Base from 1st September 2023 to cater for 20 children in EYFS/KS1 and KS2 groups.
- Sutton Park Primary will undergo small scale internal reconfiguration including improving building alterations and development of the outside areas to support the curriculum development and ensure safety.
- Recent Pupil Place Planning engagement has confirmed that this planned project forms a key element of the LA's plan to meet community needs.
- Birmingham City Council's SEND & inclusion strategy includes a commitment to establish more resource provision in mainstream settings providing a bridge between mainstream and specialist provision. There is currently a shortage of primary ASD resource provision in the local area.
- The board discussed capacity and transparency.

**Project:** To discuss a 12 place Autistic Specialist Resource Base at Prince Albert Junior and Infant School, Birmingham.

# AB discussion:

- Prince Albert Junior and Infant School, Birmingham is an Ofsted rated 'Outstanding' from February 2015. The Academy wish to create a 12 place Autistic Specialist Resource Base from 1st September 2023 to cater for children in EYFS/KS1 and KS2 groups.
- Prince Albert Primary will undergo small scale internal reconfiguration including improving sensory rooms/areas and development of the outside areas to support the curriculum development and ensure safety.
- Recent Pupil Place Planning engagement has confirmed that this planned project forms a key element of the LA's plan to meet community needs.
- Birmingham City Council's SEND & inclusion strategy includes a commitment to establish more resource provision in mainstream settings providing a bridge between mainstream and specialist provision. There is currently a shortage of primary ASD resource provision in the local area.
- The board discussed capacity and transparency.
- The board supported the recommendation.

**Project:** To discuss an Autistic Specialist Resource Base for 56 children at Prince Albert High School, Birmingham.

- Prince Albert High School, Birmingham is a Free School that opened in 2021 and has not received an Ofsted Inspection. The Academy wish to create an Autistic Specialist Resource Base from 1st September 2023 to cater for 56 children.
- Prince Albert High will undergo small scale internal reconfiguration including sensory rooms/areas and development of the outside areas to support the curriculum development and ensure safety.

- Birmingham City Council's SEND & inclusion strategy includes a commitment to establish more resource provision in mainstream settings providing a bridge between mainstream and specialist provision. There is currently a shortage of primary ASD resource provision in the local area.
- The board discussed capacity and transparency.
- The board supported the recommendation.

**Project:** To discuss an expansion of the Special Resource Provision at Whittle Academy, Coventry.

# AB discussion:

- Whittle Academy, Coventry is an Ofsted rated 'Good' from June 2018. The Academy wish to establish an SEN unit for up to 10 pupils. The provision will support pupils with moderate learning difficulties (MLD), speech, language and communication needs (SLCN) and autistic spectrum disorder (ASD).
- Whittle Academy and Inspire Education Trust approached Coventry City Council (CCC) to help initiate the LA's sufficiency strategy to create a series of Extended Resource Provisions (ERP) across the city.
- The project forms a key part of the LA's plans to meet the needs of the local SEND population.
- The board discussed the schools' approach to SEND.
- The board supported the recommendation.

RD decision: Approve.

Further actions required: To inform the school.

**Project:** To discuss a new Special Resource Provision at Courthouse Green Primary School, Coventry.

- Courthouse Green Primary School, Coventry is an Ofsted rated 'Good with potential for Outstanding' from February 2020. The Academy wish to establish a SEN unit for up to 10 pupils with complex cognition and learning needs.
- There is increasing demand for specialist placements across Coventry LA. Courthouse Green already has a purpose built provision in which to accommodate these additional 10 pupils.

• The board supported the recommendation.

**Conflicts:** Guy Shears was not present and did not receive the papers for this project.

Further actions required: To inform the school.

**Project:** To discuss an expansion of the Special Resource Provision at Alderman's Green Primary School, Coventry.

# AB discussion:

- Alderman's Green Primary School has not received an Ofsted inspection since converting to an academy on 1 April 2021. Prior to conversion, the school was judged RI in December 2018. The Academy wish to expand the Enhanced Resource Provision to create 6 additional places, 26 places in total.
- There is increasing demand for specialist placements across Coventry LA. Courthouse Green already has a purpose built provision in which to accommodate these additional 6 pupils.
- The board supported the recommendation.

RD decision: Approve.

**Conflicts:** Guy Shears was not present and did not receive the papers for this project.

Further actions required: To inform the school.

**Project:** To discuss an expansion of the Special Resource Provision at Rokeby Primary School, Warwickshire.

# AB discussion:

- Rokeby Primary School, Warwickshire, wish to increase the academy's Special Resource Provision (SRP) from 7 places to 10 at the request of the Local Authority.
- The LA identified that Rokeby Primary School was demonstrating strong practise in Special Educational Needs, which led to them opening a resource provision for children with Speech, Communication and Language needs.
- The board supported the recommendation.

# Further actions required: To inform the school.

**Project:** To discuss a physical expansion at Regency High School, Worcester.

# AB discussion:

- Regency High School, Worcester, is an Ofsted rated 'Good' from 2015. The academy wishes to expand the premises of the special school.
- The Local Authority has requested that Regency High School increase its intake by 30 students in addition to the yearly cohort from September 2023.
- The board supported the recommendation.

# **Trust Change**

Points discussed in relation to academies moving to another trust.

**Project:** To discuss The Priors School SAT, Warwickshire, to transfer to The Warriner MAT, Oxfordshire.

# AB discussion:

- The Priors School SAT, Warwickshire, is a Single Academy Trust that is on Church of England Voluntary Controlled (VC) articles. WMAT has several schools with a similar profile (small, rural) and The Priors feels that it will be well-supported.
- The Warriner MAT consists of 14 academies across Oxfordshire and South Northamptonshire.
- There is an established working relationship between The Priors and WMAT, with the school contributing to the further development of the trust's primary curriculum, benefitting the trust schools' pupils and staff.
- The board discussed the trustees and the geography.
- The board supported the recommendation.

# RD decision: Approve.

Further actions required: To inform the Trusts.

**Project:** To discuss United Endeavor Trust, Staffordshire, to transfer to Windsor Academy Trust, Dudley.

# AB discussion:

- United Endeavor Trust, Staffordshire, decided to merge with a larger trust following publication of the SWP.
- Windsor Academy Trust consists of 9 academies across Dudley, Staffordshire and Walsall.
- WAT's culture and values align very closely with UET's and the transfer of UET to WAT meets WAT's seven principles of growth.
- The board supported the recommendation.

# **Free School Presumption**

**Project:** To discuss and consider the sponsor for the new Free School in Staffordshire.

# AB discussion:

- Staffordshire County Council has identified the need to establish a new primary free school, with early years provision, at the Dunstall Farm housing development site in Tamworth. The school will open in September 2024.
- It is proposed to open a 1 FE (210-place) primary free school at the Dunstall Farm development site in Tamworth by the earliest date of September 2024. The school will be designed to enable further expansion by 0.5FE in the future if required.
- Staffordshire County Council are supportive of ATLP as the strongest bidder, Regions Group and ESFA colleagues support the choice of ATLP for this project.
- The board discussed secondary performance.
- The board supported the recommendation.

# RD decision: Approve.

# Conflicts: None.

Further actions required: To inform the LA and Trust.

**Project:** To discuss and consider the sponsor for the new Free School in Staffordshire.

# AB discussion:

- Staffordshire County Council has identified the need to establish a new primary free school with early years provision at the former Tamworth Golf Course site. This new free school is required to mitigate the impact of the Tamworth Golf Course housing development of 1100 dwellings. The school will open in September 2024.
- It is proposed to open a 1 FE (210-place) primary free school. The school will be designed to enable further expansion by 1FE in the future.
- Staffordshire Country Council are supportive of Fierté Multi-Academy Trust as the strongest bidder, Regions Group and ESFA colleagues support the choice of FMAT for this project.
- The board supported the recommendation.
