Introduction

Hello. I'm Aggie Michael, a civil servant from the Grenfell Tower site management team. This update gives you information on works happening at the site, and how to get in touch. Our contact details are on each slide and at the end of this update.

The future of Grenfell Tower

We know how important and sensitive a decision on the future of Grenfell Tower will be and a decision has not yet been made. The government is committed to supporting bereaved families, survivors and local residents and their work to determine a future memorial and we have been having conversations with them to understand their views. This includes a community meeting with the secretary of state held earlier this summer. A summary of the meeting can be found at <u>Grenfell Community Updates on GOV.UK</u>

Site maintenance

Grenfell Tower site contractors, DUK, carry out regular maintenance and checking of the props (or supports) in the tower, the site hoardings and gates, the lighting and alarm systems, and the 24-hour security system.

They inspect the scaffolding around the tower each week and carry out any necessary maintenance.

Lighting around the site is controlled using motion sensors and timers. The timings of the banner lighting are adjusted every two weeks, according to sunset time.

Air quality monitoring

The air quality in the Grenfell Tower area is monitored and assessed to understand if there is a risk to health. This includes the tower site to assess any effects on air quality of site works.

Current evidence suggests the risk to public health from air pollution in the area remains low.

We are aware of the health concerns in the community and work closely with NHS England so that anyone worried about their health can access the support they need.

Lancaster West Estate refurbishment

We work with the local council to minimise any disruption from both the maintenance of the Grenfell Tower site and the refurbishment and management of the Lancaster West Estate. Please contact <u>www.weareW11.org/en</u> for more information.

Some of the works require council contractors to access the Grenfell tower site and garage areas. We have let the council know that their drivers should act with consideration when attending the site and passing through the entrance gates to avoid disturbing residents.

Our site hours are 7am to 5pm and any vehicle movements outside those times should be by exception only.

Social value and local opportunities

An important part of the work of the tower site contractors, DUK, is to provide long-term and sustainable initiatives for the community through social value. This includes employment, training, and other projects.

Some of the initiatives provided so far include construction jobs, funding to assist local organisations with office and IT equipment, and free careers advice at local DWP centres.
