- The board reflected that the trust will want to develop its relationship with local authorities and local trusts as it increases its presence in the North West.

- The board reflected on Walton-Le-Dale being a multiple Requires Improvement school rather than Inadequate.
- The board shared reservations regarding the governance model with only 4 trustees currently in place.
