

We can confirm that we do hold the requested information. We will answer your questions in turn below:

## 1.Does your organisation use Customer Relationship Management (CRM) software? (Example: HubSpot, Salesforce, Dynamics, Other, etc.)

We can confirm we do use CRM software.

### 2. If yes, please specify which CRM(s) are used by your organisation:

We can confirm we use Dynamics software.

#### 3. What license level/subscription does your organisation have?

Dynamics Customer Service Enterprise licences, purchased via a public sector Microsoft Enterprise Agreement.

#### 4. What is the annual cost of your CRM system(s)?

We can confirm we have 1,055 Dynamics 365 Customer Service Enterprise licenses for Homes England at a cost of £529.56 per license per year (total per year is £558,685.80)

## 5. List any job roles by (job title) within your organisation that communicate with contacts via the CRM(s) system?

We can confirm that we do hold the requested information. However, we rely on Section 40(2) of the FOIA to withhold some of the information from disclosure.

#### Section 40 – Personal information

We are withholding some information from disclosure on the grounds that in constitutes third party personal data and therefore engages section 40(2) of the FOIA. Some of the requested information contains information about less than 10 individuals. Although it is not possible to identify the individuals directly from this information, we consider that the individuals are indirectly identifiable, as this information could be paired with other available information that would enable their identification. This would breach one or more of the data protection principles.
