- 3. For item 3a RMI confirmed that the R&D team will provide TAW-SAG with regular progress updates on research projects. It was confirmed that for item 3c members will provide thoughts or feedback on productive forestry, or any other topic, through email to RMK and copied to the group.

Item 3. Programme Board Update including Annual Review

- 5. BM provided an update from the Programme Board.
- 6. The key points of the Programme Board were:
 - a. The programme is at its mid-point.
 - b. The priorities for the programme were discussed, these include—
 i.achieving the best value for money (VFM) with the budget remaining and preparing for the next Spending Review.
 - ii.Ensuring the transformational work setting the foundations for trees post NCF are well established. This includes the monitoring and evaluation work and the R&D package, the importance of timber and boosting timber production in England.
 - c. There were discussions around woodland for water, stacking, and communications to help farmers and landowners understand how to make money from woodlands.
 - d. JW provided an update on the Annual Review which has been underway to review programme progress and evaluate VFM and direct resource to where it's required where gaps are found.
 - e. CQ mentioned the Defra led external stakeholder event acknowledged a lot of effort that the team had made to make the NCF quite responsive. Positive feedback from the day that good progress is being made.

- 7. RMK thanked all members for their contribution and continued effort for the review. Feedback on the process was welcomed.
 - a. It was agreed the knowledge review should be published as an academic paper.

8. Summary of Key Points raised in the feedback discussion:

- a. It would have been helpful to get the level of detail required for the paper, at the beginning of the process.
- b. A short summary at the start was helpful.
- c. There is an opportunity to share with the Devolved Administrations once it's published as they have been having these conversations as well.
- d. During the process the paper evolved at different rates and at times it was unbalanced. A workshop to discuss the paper may have been useful before going away to work on it.

- e. Are TAW-SAG there to provide an objective knowledge review or is there an element for interpretation? A clear distinction in the brief would have been very helpful. DD confirmed that policy would welcome interpretation. Follow up questions to policy are welcome throughout the process and it's good to show differing views.
- f. Need to allow just as much time as collating, to distil the evidence.
- g. If more time was available, this would have allowed the group to show gaps and strengths of evidence.

- Action 5: RMK to consider academic publication of the review.
- Action 6: RMI to consider the opportunity to share with Devolved Administrations.
