Goods Vehicles (Plating and Testing) Regulations 1988

Please use this form if your vehicle was approved under the European Community Whole Vehicle Type Approval or National Small Series Type Approval schemes and has been issued with either :-

A Certificate of Conformity for an "incomplete" approval cannot be used by DVSA to create a vehicle record. Please ensure that any "incomplete", approval is accompanied by the final stage approval for the "completed" vehicle.
