- Box I.1 The name of the country of the central competent veterinary authority (CCVA) which has the legal authority to verify and certify the conformity to the attestations.
- Box I.2 The number used by the CCVA of the country to identify the certificate. The certificate number must appear on each page of the certificate.
- Box I.3 The name of the central competent veterinary authority (CCVA) which has the legal authority to verify and certify the conformity to the attestations.
- Box I.4 The name of the local competent veterinary authority (CCVA) which issued the certificate.
- Box I.5 The natural or legal person or entity dispatching the consignment.
- Box I.6 The natural or legal person or entity to which the consignment is destined at the time the certificate is issued.
- Box I.7 The name of the country where the products were collected from animals, processed and/or manufactured.
- Box I.8 The name of the country of destination of the products.
- Box I.9 The name and address of the place(s) from which the products are being exported and official approval number when required.
- Box I.10 The name of the point of entry where the product will be entering Canada.
- Box I.11 The name of the seaport, airport, freight terminal, rail station or other place at which the products are loaded onto the means of transport being used for their carriage.
- Box I.12 The date when the product left for Canada.
- Box I.13 The description of the product or use the titles as they appear in the Harmonized System of the World Customs Organization.
- Box I.14 The six-digit Harmonized System (HS) code is the common product identifier set up by the World Customs Organization. When several codes are possible, the exporter must confirm with the importer the correct code.
- Box I.15 Technical use: animal by-products or derived products unfit for human or animal consumption.
- Box I.16 The appropriate temperature category (ambient, chilled, frozen) for transport and storage of the products.
- Box I.17 The means of transport from the exporting country to Canada at the time the certificate is issued: for air transport, name of the airline and flight number; for maritime transport, the name of the vessel and the voyage number; for rail transport, the number of the train and the wagon and for road

transport, the registration number of the road vehicle and the number of the trailer where used.

- Box I.18 The identifications of the containers and seal numbers. Markings (such as company logo, name or other) must be clearly described.
- Box I.19 For products only transiting through Canada, indicate the name and the ISO code of the country of destination.
- Box I.20 The title(s) and reference number(s) of any relevant accompanying documents.

Box I.21 Description and identification of the commodities

- Manufacturing Plant and CCVA Approval Number - The establishment where the product was produced, including the approval number.
- Common Name of Product - *Common name* means the name by which the product is generally known.
- Species of origin - The scientific name of the animal from which the product was derived.
- Type of Packaging - The type of packaging used to ship the products (drums, barrels, cartons, etc.).
- Number of packages - The number of packages in the consignment.
- Net quantity - The net quantity of the product indicated by volume or weight in metric units.
- Lot or batch number - The lot identification system developed by the manufacturer to account for their production of the products.
