In accordance with the Data Protection Act and our obligations in relation to the protection of confidentiality when handling personal data, data have been rounded to the nearest 10, "~" denotes a number less than or equal to 5. Due to the rounding methods used, totals may not always equal the sum of the parts. When rounding to the nearest 10, numbers ending in 5 have been rounded to the nearest multiple of 20 to prevent systematic bias.

Data has been provided by the Royal Air Force (RAF) 22 Group for Table 1 and RAF Recruitment and Selection for Tables 2 – 6.

Under Section 16 (Advice and Assistance), it may be helpful for you to know that due to the variable length of the recruitment process, entrants to service may have applied in previous Financial Years, in addition, in Financial Year 2021 and 2022, application numbers for the pilot branch were lower as Direct Entry applications for this branch were closed from October 2020.

If you are not satisfied with this response or wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MoD internal process has been completed.
