JUDGMENT

The claimant's claim for unfair dismissal is well founded and succeeds. She was made redundant by email at 13.24 on 20 February 2023 after 18 years service as a part time bookkeeper. The respondent has not defended the claim, was given notice of the remedy hearing and was copied into the schedule of loss information provided to the tribunal and has chosen not to make representations nor attend.

The claimant's claim for breach of contract notice pay is well founded and succeeds. She was dismissed without notice.

The respondent is ordered to pay to the claimant £ £ 5579.00 made up as follows: (and rounded down to no decimal places)

Basic award of statutory redundancy pay

3 years x 1(under age 41) x £130 gross week's pay

+ 15 years x 1.5 (over age 441) x £ 130 =

THE EMPLOYMENT TRIBUNALS (INTEREST) ORDER 1990 ARTICLE 12

Case number: **2403127/2023**

Name of case: Mrs S Hill v Amazing Glazing (Widnes) Ltd

Interest is payable when an Employment Tribunal makes an award or determination requiring one party to proceedings to pay a sum of money to another party, apart from sums representing costs or expenses.

No interest is payable if the sum is paid in full within 14 days after the date the Tribunal sent the written record of the decision to the parties. The date the Tribunal sent the written record of the decision to the parties is called **the relevant decision day**.

Interest starts to accrue from the day immediately after the relevant decision day. That is called **the calculation day**.

The rate of interest payable is the rate specified in section 17 of the Judgments Act 1838 on the relevant decision day. This is known as **the stipulated rate of interest**.

The Secretary of the Tribunal is required to give you notice of **the relevant decision day**, **the calculation day**, and **the stipulated rate of interest** in your case. They are as follows:

the stipulated rate of interest is: 8% per annum.
