<p>RA1010- A re-write of RA 1010, including a title change, to now include all of the RAs that use to be in RA 1026 that related to either a HoE or ADH / AM (MF) and also incorporates RA 2415 which has subsequently been withdrawn. The terminology for unlicensed civilian sites has also been simplified and made clearer for the RC to understand. In addition, a flowchart has been included to assist HoE to decipher what tier their establishment should fall under.</p> <p>RA1026- Removed all of the RA's that are applicable to HoE and ADH / AM(MF) and transferred across into RA 1010 to ensure that RA 1026 only contains the information iaw the title of the RA. This has resulted in the removal of the following Regs within RA 1026 – (1), (5), (6) and (7) with the addition of (9) and (10) to align AS(RF) with AO and the DAM. The SQEP requirements for an AO and AS(RF) have been amended to make it clearer on what is meant by command experience and the addition of having to attend AOSP instead of having to attend DHASC.</p>
