Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation of an environmental permit.

The permit has been varied at the request of the operator to amend the permit boundary by partially surrendering part of the permitted area which was not used for the deposit of waste. The operator will continue to have permission to discharge to and access the surface water lagoon in the area of land which has been surrendered. No landfill gas or groundwater monitoring boreholes will be removed as part of this variation and the operator will continue to have access all of the perimeter and other monitoring points. The registered office address has also been updated.


