Introductory note

This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

The variation is to update the site plan to show the emission point to sewer as a result of changing the electrolysis technology for producing hydrogen to a GHS HyProvide A90 Electrolyser. This results in an effluent that is discharged to sewer at a rate of approximately 9 m³/day. The changes to the activities are still within the criteria of the standard rule set.

The schedules specify the changes made to the original permit.

We consider that in reaching our decision to vary the permit we have taken into account all relevant considerations and legal requirements and that the permit will ensure at least an equivalent level of protection to human health and the quality of the environment.
