We can confirm the value awarded was £2,723,588.00

- what was the critical that the funding was awarded for

We can confirm that the critical funding was awarded for UPVC spandrel panels, identified as painted plywood (class C or D) with EPS insulation (class E) with render applied to mineral wool insulation (Class A)

- how many quotes did Aspect 3 supply for this funding

We can confirm that there were no quotes received as the Building Safety Fund application process requires applicants to submit a single cost for grant funding (see value awarded sum above)

- who was the contractor that was awarded the work to replace the cladding

We can confirm the contract was awarded to SCF Stone Cladding Facades Ltd.
