Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

The current Affordable Homes Programme, which runs until 2026, has a target that 25% of homes delivered through strategic partnerships must be built using modern methods of construction (MMC). However, Homes England's other MMC targets have not been made public.

Please may you provide me with:

- **What Homes England's other MMC targets are**
- **How many homes still to be built under the Affordable Homes Programme are supposed to be built using MMC**
- **Of these, how many homes are supposed to be category two MMC, ie panellised factory-built walls/floors/ceilings, and how many are supposed to be category one MMC, ie fully modular homes built in a factory**

Response

We can confirm that Homes England does not hold the information detailed in your request.

To conclude that the information is not held, we have searched with our Operational team who would have the requested information if held.
