# AMENDED JUDGMENT

Employment Tribunals Rules of Procedure 2013 - Rule 21

- <u>Claim 1403177/2022</u> was issued in the Southampton Employment Tribunals on 3 Oct 2022; <u>claim 1403663/3033 on 15 November 2022</u>. The respondent has failed to present a valid response <u>to either claim</u> on time. The Employment Judge has decided that a determination can properly be made of the claim, or part of it, in accordance with rule 21 of the Rules of Procedure.
