JUDGMENT ON REMEDY

- 1. The Tribunal makes a protective award under section 189 of the Trade Union and Labour Relations (Consolidation) Act 1992 in favour of the Claimants listed in the Schedule attached ("Schedule 1") against the Respondents listed in that schedule.
- 2. The protected period begins on **13 June 2022**. The Respondents are ordered to pay remuneration to the Claimants in Schedule 1 for the protected period which:
 - a. **85** days in respect of those employees identified on Schedule 1 as being employed by 'Rutherford Cancer Care Limited' and 'Rutherford Health Plc'.
 - b. **75** days in respect of those employees identified on Schedule 1 as being employed by 'Rutherford Diagnostics Limited'.
- 3. The Employment Protection (Recoupment of Jobseeker's Allowance and Income Support) Regulations 1996 ('the Regulations') apply to the protective award.
