Converter Academy Orders

Points discussed in relation to school conversion.

Project: To discuss Hackness Church of England Voluntary Controlled Primary School, North Yorkshire to convert and join Elevate Multi Academy Trust.

AB Discussion:

- This item was discussed alongside Wykeham Church of England Voluntary Controlled Primary School, North Yorkshire, to convert and join Elevate Multi Academy Trust.
- Hackness and Wykeham Church of England Schools Federation formed in 2016. The federation consists of two small rural primary schools situated in the villages of Hackness and Wykeham in the North York Moors, near Scarborough in North Yorkshire. As such, it is part of the Priority Education Investment Area.
- Both schools are RI with a shared executive headteacher. The headteacher and governing body recognise the need for additional support from a MAT to accelerate improvement. They have identified Elevate as their preferred trust, citing the professional development and central trust support available. The federation also believes that joining Elevate will provide additional financial stability and security to the two schools. The schools share a federated budget and work in close collaboration. Both schools have 3 mixed age classes and do not have nursery provision.
- The Board considered the Trust's financial forecasts in light of current pressures on budgets. It was considered that the Trust has appropriate experience of running similar schools.
- Board members agreed with the schools' view that they would benefit from joining a strong MAT, and that Elevate had the experience and capacity to provide the required support.
- Advisory Board members gave their support of this item. It was confirmed that this item would need to be referred to Katherine Cowell, North East Regional Director, for a decision to be made.

AB Discussion:

- This item was discussed alongside Hackness Church of England Voluntary Controlled Primary School, North Yorkshire, to convert and join Elevate Multi Academy Trust.
- Hackness and Wykeham Church of England Schools Federation formed in 2016. The federation consists of two small rural primary schools situated in the villages of Hackness and Wykeham in the North York Moors, near Scarborough in North Yorkshire. As such, it is part of the Priority Education Investment Area.
- Both schools are RI with a shared executive headteacher. The headteacher and governing body recognise the need for additional support from a MAT to accelerate improvement. They have identified Elevate as their preferred trust, citing the professional development and central trust support available. The federation also believes that joining Elevate will provide additional financial stability and security to the two schools. The schools share a federated budget and work in close collaboration. Both schools have 3 mixed age classes and do not have nursery provision.
- The Board considered the Trust's financial forecasts in light of current pressures on budgets. It was considered that the Trust has appropriate experience of running similar schools.
- Board members agreed with the schools' view that they would benefit from joining a strong MAT, and that Elevate had the experience and capacity to provide the required support.

Project: To discuss Threshfield Primary School, North Yorkshire, to convert and join Yorkshire Collaborative Academy Trust.

AB Discussion:

- Threshfield School is a small, rural, voluntary controlled primary school located in Threshfield village, Skipton. In June 2014 and May 2016, Threshfield School received Ofsted requires improvement reports highlighting outcomes for children as the main area to improve. The current headteacher was appointed to the school in 2017 and on 4 July 2018 the school received a good Ofsted report.
- The Board considered the Trust's finances and School Financial Support and Oversight colleagues are working closely with the trust. The trust is awaiting the final report from the recent School Resource Management Adviser deployment and has provided information on the strategies they have in place to mitigate against any future deficits. Declining pupil numbers across the Local Authority were discussed.
- Board members were supportive of the project, whilst noting the Trust's recent growth.

Project: To discuss Oakfield Community Special School, North Yorkshire, to convert and join The Consortium Academy Trust.

AB Discussion:

- Oakfield school is a co-educational school for both day and residential pupils who have social, emotional and mental health needs. The school caters for pupils between the ages of 11 and 16 years who have an Education, Health and Care Plan for Special Educational Needs. They can currently accommodate up to 110 pupils and residential provision that can accommodate up to 34 pupils.
- The viability of the residential element was discussed given the current take up of the provision. Board members advised that more detailed financial modelling of different scenarios would be beneficial and reassurance that the trust has a good understanding on how SEND funding works within the system.
- The Board discussed the trajectory of the Trust's academic performance and agreed that it would be helpful to have more detail on the Trust's school improvement model and how they are investing in and embedding school improvement across the trust.
- It was decided that the most appropriate decision with regards to this item would be to defer it and to bring it back to a future Advisory Board meeting.

- This item was discussed alongside Old Town Primary School, Calderdale, to convert and join Pennine Academies Learning Trust, Midgley School, Calderdale, to convert and join Pennine Academies Learning Trust. and Todmorden High School, Calderdale, to convert and join Pennine Academies Learning Trust.
- There is currently no MAT presence in the West of Calderdale (Hebden Bridge and Todmorden) which has much smaller and several rural/village schools. Schools in this area are looking to formalise their pre-existing relationships by coming together under one MAT. The 6 founding schools have all stated that they have a shared vision and ethos and believe that the MAT will provide an all-through academic and personal development pathway for West Calderdale children and young people ages 3-16.
- The Board considered the Trust's future financial forecasts once the six schools have formally created the new trust, SFSO colleagues were content that any financial risks were manageable.
- Board members recommended that the Trust's CEO and CFO need to be full time positions (or equivalent, such as jobshares) because there will be extensive leadership and financial work needed as this trust is established – as such the Regional Director made this a condition of approval. The Regional Director would also like to see mentoring arrangements for both the CEO and CFO. - The work undertaken by the CEO in supporting other trusts was recognised by the Board, as was the track record of school improvement and the healthy financial forecasts. It was agreed that Selby Education Trust was a good option for growth and to take on the school.

- Sherburn CofE VC Primary School and Luttons Community Primary School are federated, sharing leadership and a governing body. In June 2022, Sherburn was judged inadequate by Ofsted. At the time, several sponsor options were considered and in discussion with the Diocese of York, Ebor Academy Trust was approached to conduct due diligence on Sherburn. Separately, Ebor was approached by North Yorkshire Council to provide leadership capacity across the federation. An Ebor headteacher was seconded by the federation and started in January 2023.
- The forecasted pupil numbers for the schools were discussed, and it was agreed that Ebor has the expertise of running similarly sized schools.

AB Discussion:

- Sherburn CofE VC Primary School and Luttons Community Primary School are federated, sharing leadership and a governing body. In February 2023, Luttons was inspected and judged to be inadequate so Ebor's due diligence process then took into account both of the schools.
- The forecasted pupil numbers for the schools were discussed, and it was agreed that Ebor has the expertise of running similarly sized schools.
- The Advisory Board gave their support to this project.

The percentage of pupils eligible for free school meals at any point over the last six years is 31%, above the national average. Pupils are predominately white British, with very few speaking English as an additional language and the level of pupils with an EHCP is also slightly above the national average.

- There was a discussion about the governance structures of LGAT and how they could be strengthened by increasing the amount of separation across the different levels of governance.
- It was noted that the Local Authority of supportive of the proposal.

Three of the academies are judged as 'Good' by Ofsted, with the other three judged as 'Requires Improvement'. The trust was issued with a Termination Warning Notice relating to Victoria Primary School on 16 June 2023. This was following Victoria Primary School being judged 'Requires Improvement' by Ofsted in November 2019 and falling into scope for the 2RI+ intervention powers which came into force in September 2022. This contributed to a full review of the trust's capacity for school improvement. A School resource management advisers visit and External Review of Governance had previously confirmed concerns around the financial viability, sustainability and compliance of the trust.
- Nurture Academies Trust has agreed to voluntarily dissolve and transfer all of its schools to a new Trust.
- It was agreed that Northern Star Academies Trust would be a suitable trust for these schools to join.

AB Discussion:

- This item was discussed alongside Burnley Road Single Academy Trust, Calderdale, to transfer to Pennine Academies Learning Trust.
- Wainstalls School is a village school currently part of I-trust Education Multi Academy Trust. Pupil numbers are stable although there is expected to be a slight decline in the next 3 years as part of the trend in the Local Authority. In 2016, the school expanded their pupil admission number from 21 to 30 to cater for the increase demand and popularity of the school.

- The Regional Director's view is that the Multi Academy Trust will need more of the time of the incumbent Chief Executive Officer and Chief Finance Officer to achieve the rapid maturing of the Multi Academy Trusts plans. The trust to provide the Regional Director's team with a scheme of delegation within three months of this approval.

AB Discussion:

- This item was discussed alongside Wainstalls School, Calderdale, (I-trust to dissolve trust) to transfer to Pennine Academies Learning Trust.
- Burnley Road Academy became a Single Academy Trust in September 2011 and has been looking at their Multi Academy Trust options since the beginning of this academic year. They are keen to join the proposed new Multi Academy Trust given that Calder High is the main feeder school where the majority of their children move onto and to be able to share best practice and resources.
