REQUEST FOR INFORMATION: Ivory Chess set exemptions granted

Thank you for your request for information of 8th June about Ivory Chess set exemptions granted. APHA have handled your request under the Environmental Information Regulations 2004 (EIRs).

The EIRs apply to requests for environmental information, which is a broad category of information defined in regulation 2 of the EIRs. Public authorities are required to handle requests for environmental information under the EIRs. They give similar access rights to the Freedom of Information Act 2000 (FOIA).

Your information request and our response are set out below.

"Under the Freedom of Information Act please advise the number of chess set exemptions made and granted since the beginning of the Act until May 2023 or the latest date available.

Background

At the March Defra internet meeting of the Ivory Users Group we were informed of the percentage of chess sets which had received or requested exemption from the Act under section 10.

However, in the recent June meeting we were simply informed that to date, 150 section 10 applications had been made under the Act with 112 exemptions granted.

Two rare and most important chess set collections have already been removed to mainland Europe and I wish to remind UK collectors that exemptions can be and have been granted for rare and most important items. In the meantime I am revising the guidance notes of overseas R & MI chess sets."

APHA can confirm we have received 19 and granted 13 exemption applications for chess sets since the beginning of the Act to date.

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

Information disclosed in response to this EIR request is releasable to the public. In keeping with the spirit and effect of the EIR and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
