Environmental Information Regulations – Information Request

We refer to your request for information dated 18 May 2023 which we have dealt with under the Environmental Information Regulations 2004 (EIR).

You have asked the following questions: -

- How many people are currently employed within the Rural Payments Agency whose job involves (a) processing and (b) inspecting claims made under the Basic Payment Scheme, The Countryside Stewardship Scheme, and the Sustainable Farming Incentive?
- 2) How much public money has been spent per annum on the employment of persons tasked with (a) processing and (b) inspecting claims made under the Basic Payment Scheme, The Countryside Stewardship Scheme, and the Sustainable Farming Incentive over the previous five years (2018 - 2023)?
- 3) How much public money has been paid out to farmers and landowners per annum over the last five years (2018 to 2023) under (a) the Basic Payment Scheme and (b) The Countryside Stewardship Scheme and (c) The Sustainable Farming Incentive.
- 4) In the last five years (2018 to 2023) how much money has been proved to have been defrauded from the public purse by farmers or landowners (or their representatives) claiming public money under the Basic Payment Scheme, The Countryside Stewardship Scheme, and the Sustainable Farming Incentive on an annual basis?
- 5) Have any of the cases in paragraph 4 led to criminal prosecution?

We have considered questions three, four and five under the EIR.

Please find below the total amounts paid per annum under the Basic Payment Scheme (BPS), the Countryside Stewardship (CS) scheme and the Sustainable Farming Incentive (SFI) between 2018 and 2023.
