EXPORT OF CAPRINE HAIR TO REPUBLIC OF MEXICO

NOTES FOR GUIDANCE OF THE EXPORTER AND OFFICIAL VETERINARIAN

Associated Documents: 7051EHC, 618NDC and 372DMR.

IMPORTANT

These notes provide guidance to Official Veterinarians (OV) and exporters. The NFG should have been issued to you together with export certificate 7051EHC. The NFG should not be read as a standalone document but in conjunction with certificate 7051EHC. We strongly suggest that exporters obtain full details of Mexico's requirements from the veterinary authorities there, or their representatives in the UK, in advance of each consignment.

1. Scope

7051EHC may be used for the export of caprine hair from the United Kingdom to Mexico.

NOTE :

In the event of the consignment transiting any other country en route to Mexico, the Mexican veterinary authority requires additional export certification from the country of 'immediate origin.'

2. Certification by an Official Veterinarian (OV)

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government, Welsh Government or the Department of Agriculture, Environment and Rural Affairs (DAERA) Northern Ireland, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary) (OCQ(V)) authorisation.

OVs must sign and stamp the health certificate with the OV stamp in any ink colour **OTHER THAN BLACK**.

Certified Copy Requirements - England, Wales and Scotland

Guidance concerning return of certified copies of EHCs has changed and only specific certified copies are required to be returned to the APHA. Certifying OVs must return a certified copy of EHCs only for the following EHC types:

if the exported commodity is cattle, pigs, sheep, goats or camelids;
if the certificate was applied for manually and the application documents have been emailed to APHA and not applied for via the Exports Health Certificates Online (EHCO) system.

Certified copies should be emailed on the day of signature to the Centre for International Trade Carlisle (CITC) at the following address: certifiedcopies@apha.gov.uk.

For certificates that have been issued to the Certifying OV via the EHCO system, the Certifying OV must complete the certifier portal with the status of the certificate and the date of signature.

A copy of all EHCs and supporting documentation certified must be retained for two years.

Certifying OVs are not required to return certified copies of other EHCs issued, however CITC may request certified copies of EHCs and 7051NFG (Cleared 07/09/2010) (Revised 11/10/2023) supporting documentation in order to complete Quality Assurance checks or if an issue arises with the consignment after certification.

DAERA Export Health Certificates: Provision of certified copies

aPVPs certifying DECOL produced Export Health Certificates must return a legible, scanned copy of the final EHC to the relevant DAERA Processing Office within 1 working day of signing.

Good quality photographic copies will be accepted by the department, where obtaining a scanned copy is not feasible - for example, where 'on site' certification is undertaken and scanning facilities are not available.

For record purposes, a copy of the final Export Health Certificate and associated Support documents should be retained by the aPVP for a period of 2 years from the date of certification.

The Department will carry out periodic audits of all aspects of export certification to ensure that a high standard of certification is being maintained.

- **3.** Paragraph I. (a) refers. The consignment description should include reference to the species of origin of the product.
- 4. Paragraphs IV. 1 and 2 (b) refer. These paragraphs may be certified on the basis of familiarity with the factory sourcing procedures and processes in place, supported by relevant documentation and/or suitable records (such as slaughter/treatment/testing records, commercial documentation, veterinary certification).

The certifying OV should be familiar with the conditions of Regulation (EC) No 1774/2002. Electronic copies of this Regulation and subsequent amendments, as well as other pieces of EU legislation, can be obtained by searching the EU Commission's website via the following link:

5. Notifiable Disease Clearance

Official Veterinarians may certify paragraph IV. (2) (a) on behalf of the Department, provided written authority to do so has been obtained on form 618NDC from the APHA Centre for International Trade at Carlisle or from the issuing office of DAERA in Northern Ireland.

This certificate is provided on the basis of information available at the time, and may not necessarily comply fully with the requirements of the importing country. It is the exporter's responsibility to check the certificate against any relevant import permit or any advice provided by the competent authority in the importing country.
