The following notice gives notice of the variation of an environmental permit.

The Industrial Emissions Directive (IED) came into force on 7th January 2014 with the requirement to implement all relevant Best Available Techniques (BAT) conclusions as described in the Commission Implementing Decision. The BAT conclusions for incineration were published on 03 December 2019 in the Official Journal of the European Union (L323) following a European Union wide review of BAT, implementing decision 2017/2117/EU of 21 November 2017. This variation has been issued to ensure that the plant cannot operate until a full review has been carried out.

The schedules specify the changes made to the original permit.

The report shall include: i. A list of any BAT conclusions that are not relevant, including justification.		
	ii. A description of how the installation complies with the standards set out in each relevant BAT conclusion, including those for new plants.		
	The permitted activities shall only commence once the operator has obtained the Environment Agency's written approval to the report and the Environment Agency has issued a variation notice to implement new plant BAT standards.
