Thank you for your correspondence of 4 May 2023 requesting the following information:

- (1) *How many people currently serving within the Royal Air Force have a formal diagnosis of ADHD (Attention Deficit Hyperactivity Disorder).*
- (2) *If an individual serving in the Royal Air Force presents with symptoms of ADHD what is the process from there?*
- (3) *In the past 12 months has the Royal Air Force funded or undertaken themselves (perhaps within DCMH) any assessments for ADHD?*
- (4) *If the answer to (3) is yes. Please can you tell me how many were undertaken in the past year?*
- (5) *Further to (4) If Available, the information too for the prior 3 years?*
- (6) *Does the Royal Air Force accept applicants with a diagnosis of ADHD?*
- (7) *Further to (6) Does the Royal Air Force accept applicants with a diagnosis of ADHD and taking medication?*
- (8) *Further to (6) and (7) if yes to either answer. Are there any restrictions for those applicants?*
- (9) *If a service person is diagnosed with ADHD are they able to continue to serve?*
- (10) *Further to question (4) Of those people [assessed in the last year] how many were medically discharged within 12 months of receiving an ADHD diagnosis."*
- (11) *Does having an ADHD diagnosis prevent you from applying for some roles within the Royal Air Force, and if yes, which roles?*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA). A search for the information has now been completed, and I can confirm that information in scope of your request is held.

Information relating to questions 6, 7, 8 and 9 has been withheld under Section 21 of the FOI Act, as it is available to you by other means. The most recent version of the Joint Service Manual of Medical Fitness, JSP 950 Medical Policy Leaflet 6-7-7, can be found at the below link.

The responses to the remaining questions are below:

*(1) How many people currently serving within the Royal Air Force have a formal diagnosis of ADHD (Attention Deficit Hyperactivity Disorder).*

As at 1 March 2023, there were 114 serving Royal Air Force (RAF) personnel who had a formal diagnosis of ADHD in their medical record.

*(2) If an individual serving in the Royal Air Force presents with symptoms of ADHD what is the process from there?*

If an individual is seeking assessment for ADHD, they will be referred to a Department of Community Mental Health (DCMH) by their Medical Officer. If the patient does not already have evidence of a diagnosis of ADHD in childhood, they will likely be referred into specialist NHS services for assessment. The requirement for Defence Primary Healthcare to develop and provide a specialist ADHD service to all service personnel was endorsed by the Clinical Reference Group in June 2022 and forms part of the Healthcare Improvement Programme.

*(3) In the past 12 months has the Royal Air Force funded or undertaken themselves (perhaps within DCMH) any assessments for ADHD?*

The RAF have provided assessment for Service Personnel through DCMH, however, some individuals have been referred to NHS services whilst others have pursued assessment privately.

*(4) If the answer to (3) is yes. Please can you tell me how many were undertaken in the past year?*

Between 1 April 2022 and 31 March 2023, 13 RAF personnel had a first appointment at a DCMH for ADHD.

*(5) Further to (4) If Available, the information too for the prior 3 years?*

Between 1 April 2020 and 31 March 2023, 29 RAF personnel had a first appointment at a DCMH for ADHD.

*(10) Further to question (4) Of those people [assessed in the last year] how many were medically discharged within 12 months of receiving an ADHD diagnosis."*

Of the 29 RAF personnel who had a first appointment at a DCMH for ADHD between April 2020 and March 2023, none were subsequently medically discharged within a year of the first appointment.

Please note, ADHD may not have been listed as a principal or contributory cause of the subsequent medical discharge and it may have been for an unrelated condition.

*(11) Does having an ADHD diagnosis prevent you from applying for some roles within the Royal Air Force, and if yes, which roles?*

Suitability for any role is assessed on a case-by-case basis in accordance with the specialisation selection sheets.
