Thank you for your correspondence on 20 June 2023 requesting the following information:

Please could you provide the number of pilots (including RPAS) who have retraded from a different role within the RAF? This is as opposed to direct entrant pilots.

Please could this be shown for the last 5 years, and split out by the pilots previous role.

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA). A search for the information has now been completed, and I can confirm that information in scope of your request is held.

Please see Annex A, Table 1: Non Direct Entrant Regular Pilot Intake from other areas within Trained RAF Regulars. This excludes those in the RAF Reserves.

Please note, due to the small populations generated by the level of data in the table, the figures have been rounded to protect personal information as governed by the Data Protection Act 2018, under Section 40(2) (third party personal data) of the FOI Act. Figures are rounded to the nearest 10 and therefore totals may not always equal the sum of the parts. When rounding to the nearest 10, numbers ending in 5 have been rounded to the nearest multiple of 20 to prevent systematic bias. 5 or fewer is represented by '~' unless the number is 0.

Under Section 16 (Advice and Assistance), please note that the Trade Groups are made up of various Specialisations which themselves sit under broad Professions. Please see below which Profession each Trade Group sits under as of March 2023:

Trade Group 1 and Trade Group 5 sit under the Engineering Profession.

Trade Group 4 sits under the Cyberspace Profession.

Trade Group 6 and Trade Group 18 sit under the Logistics Profession.

Trade Group 7 sits under the Air and Space Operations Profession.

Trade Group 8 sits under the Security & Resilience Operations Profession.

Trade Group 11 sits under the Intelligence Profession.

If you are not satisfied with this response or wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MoD internal process has been completed.
