#### Agenda Item 1: Lord Chancellor's Welcome

- 1. The LORD CHANCELLOR welcomed members and thanked them for the recent actions they had taken to address the issues that the Criminal Justice System (CJS) was facing.
- 2. The LORD CHANCELLOR ran through the latest prison population figures and recognised that this was a point at which the CJS risked suffering disruption. He said that he would be making an announcement on the current situation and plans to the House of Commons that afternoon.

#### Agenda Item 2: End of Custody Supervised License (ECSL) Scheme

3. AMY REES said that one of the measures being introduced to alleviate pressures on prisons was an end of custody supervised licences (ECSL) scheme which would make certain prisoners eligible for release up to 18 days before their conditional release date in targeted prisons. ECSLs

- would only be used when and where necessary and if deemed safe to do so. Those released would face strict licence conditions and could be recalled to prison at any point.
- 4. Only prisoners within 18 days of their 50% automatic release date would be eligible. There would be several exclusions from the scheme including; those on the sex offenders register or serving a sentence for a sexual offence, those convicted of terrorist offences, all violent offenders serving 4 years or more, those currently remanded in custody or serving a recall, and Category A prisoners.

### Agenda Item 3: Wider Package of Reform

- 5. ROSS GRIBBIN said that the Lord Chancellor would be announcing new policy measures that afternoon. These would include:
  - Early removal of foreign national offenders (FNO).
  - Full sentences for rape offences.
  - Suspension of short sentences.
  - Earlier termination of Imprisonment for Public Protection (IPP) sentences.
  - Changes to remand and recall.
  - Options for future prison capacity and reforms of probation services.
- 6. The LORD CHANCELLOR said that judges would remand those who did not follow court orders into custody and that the Ministry of Justice (MoJ) would double the availability of electronic tags.
- 7. ROB NIXON thanked colleagues for their ongoing work and collaboration and said that it was important to examine shifts in demand going forward.
- 8. The LORD CHANCELLOR said that the goal of this work was to cut crime. The focus would be on putting the most dangerous offenders away for longer but allowing those who could be redeemed to be rehabilitated.
- 9. MINISTER PHILP said that the Home Office (HO) supported the implementation of the measures. He said that Operation Safeguard had allowed capacity to increase and welcomed the Lord Chancellor's recommitment to an extra 20,000 prison places. However, it was important that custodial sentences remained available, particularly for prolific offenders.
- 10. DONNA JONES said that it was vital to get more courts sitting, increase the recruitment of district judges and out of court disposals.
- 11. NICK GOODWIN said that HMCTS was continuing to recruit legal advisors and that the situation in courts would improve as staff continued to gain more experience and training.
- 12. The LORD CHANCELLOR said that the immediate measures set to be announced were a temporary and targeted scheme aimed at relieving points of pressure in certain places. The wider policy changes would also help to reduce pressure on prison capacity, but moreover were part of the wider mission to cut crime.
