I, the undersigned Official Veterinarian, certify that the consignment of meat/meat products described above meets the following conditions:

- (a) Have been obtained from healthy animals;
- (b) Have been obtained from animals which, at the time of despatch for slaughter, originated from a country or a zone, free from Highly Pathogenic Avian Influenza (HPAI), Newcastle disease, and other notifiable diseases in poultry. The zoning is in accordance with the World Organization for Animal Health (WOAH) Terrestrial Code;
- (c) The meat/meat products were derived from animals, which were slaughtered in approved slaughterhouse in a country or zone free from Highly Pathogenic Avian Influenza and were subjected to satisfactory ante-mortem and post-mortem inspection conducted or supervised by official veterinarian and are fit for human consumption;
- (d) The meat/meat products were slaughtered, out, processed and stored in designated establishments of the United Kingdom;
- (e) The meat/meat products were produced, packed and transported under hygienic conditions in accordance with relevant food hygiene regulations in force in the United Kingdom;
- (f) They do not contain levels exceeding permitted limits of veterinary medicinal products and other harmful residues and comply with microbiological criteria in accordance with food law and instructions given by the competent authorities of the United Kingdom; in accordance with the relevant standards of Codex Alimentarius;
- (g) The meat/meat products are approved for human consumption.
