# *Further information provided to the Social Security Advisory Committee by the Department prior to the meeting.*

#### (a) It is assumed from the draft regulations that entitlement to Category D Pensions is covered in the withdrawal agreements, can you confirm this please?

Yes – those covered by the Withdrawal Agreement (i.e. those individuals who moved from the UK to the EU, and vice versa, on or before the 31st December 2020) will continue to benefit from the current Category D pension residence conditions. The same is true for those covered by an equivalent separation agreement (i.e. the Swiss Citizens' Rights Agreement and the EEA EFTA Separation Agreement).

#### (b) Are there other regulations like this in the pipeline?

The Department has no plans to bring forward any other SIs related to the Stewart judgment. However, the Department is using powers within the Retained EU Law (Revocation and Reform) Act 2023 to make regulations to restate two judgments of the Court of Justice of the European Union which relate to private pensions.

The Department has chosen to use the powers within the Social Security Contributions and Benefits Act 1992 to amend the legislation governing entitlement to a Category D Pension, rather than restate the Stewart judgment under the Retained EU Law (Revocation and Reform) Act 2023, because this approach is in line with the approach taken with other benefits affected by the Stewart judgment. For example, both the Social Security (Personal Independence Payment) Regulations 2013 and the Social Security (Disability Living Allowance, Attendance Allowance and Carer's Allowance) (Amendment) Regulations 2013 amended legislation to reflect the impact of the Stewart judgment.
